The QFR survey is the most comprehensive current financial survey conducted by the government. The survey results are used to prepare national measures of corporate profits, including estimates of the Gross Domestic Income, and to formulate fiscal and monetary policy. Your company's participation is critical to this effort.

**YOUR RESPONSE IS REQUIRED BY LAW.** Title 13, United States Code, requires those selected for the QFR survey to answer the questions and return the report to the U.S. Census Bureau. By the same law, responses are strictly confidential. Only sworn Census Bureau employees may see the reports, and the information contained in them will only be used for statistical purposes. Furthermore, copies retained in respondents' files are immune from legal process.
