

Debriefing Form

- 1) Hello, this is _____ from Knowledge Networks. I am calling about the survey you took earlier today/yesterday/last **day of week** that asked your opinions on communication between you and your child. - 2) First, did you find any part of the survey difficult to understand? If so, what? **[help the respondent to find the exact portion of the survey]** What made this difficult to understand? What was it that you were not sure that you understood properly? Can you suggest ways of making that part easier to understand? Where there any other parts –of the survey that you found difficult to understand? **[Repeat until R can no longer think of anything else].**
- 3) Were there any parts during the survey where you weren't sure what you were supposed to do? Specifically, what caused your uncertainty? Can you suggest ways of making that part easier to understand? Was there any other part of the survey that you weren't sure what you were supposed to do? **[Repeat until R can no longer think of anything else].**
- 4) Now, I'm going to read a few sentences of the survey and I would like you try and remember what you first thought when you read them.

Waiting to have sex is the most effective way to prevent health risks like unwanted pregnancy or HIV/STDs.

What are your expectations about talking with {CHILD NAME}? If you talk early and often with {CHILD NAME} about sexual topics (such as waiting to be sexually active until he/she is older).
