Justification for:

PD F 3565, " Application For Disposition Of Retirement Plan And/Or Individual Retirement Bonds Without Administration Of Deceased Owner's Estate."

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection.** Retirement Plan and/or Individual Retirement Bonds belonging to a deceased owner whose estate is not being administered may be redeemed upon the request and agreement of the survivors.

- 2. Indicate how, by whom, and for what purpose the information is to be used.** Used to identify the securities involved and to establish entitlement. Without the information, the transaction cannot be completed.

Public Debt has been a leader in e-Gov, providing the public with options for conducting financial transactions online for several years. To provide our customers additional options for submitting information electronically, we are taking the following steps: a technical project team is exploring options (such as pay.gov) and will select the mechanism(s)/infrastructure needed; concurrently, reengineering of business processes (and forms) is being conducted as the result of a reorganization of our major business lines.

14. **What is the annualized cost to the Federal Government?** The following factors were used to estimate the annual burden to this agency:
- a. Printing cost - estimated number of forms printed annually, multiplied by the unit cost of the forms.
 - b. Case processing cost - estimated number of forms completed, multiplied by a percentage of the unit cost of case processing.
 - c. Forms management cost - salary cost of forms management personnel.
