Justification for:

Form PD F 5263, "Order for Series EE U. S. Savings Bonds;" Form PD F 5263-1, "Order for Series EE U.S. Savings Bonds to be registered in name of fiduciary;" Form PD F 5374, "Series I Order For U.S. Savings Bonds;" and Form PD F 5374-1, "Series I Order For U.S. Savings Bonds to be registered in name of fiduciary." Securities."

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection.** Section 22, Second Liberty Bond Act, permits the Secretary of the Treasury to offer for sale to the people of the United States, United States Savings Bonds. Purchase of bonds may be made through payroll plans, over-the-counter, the Federal Reserve Banks or Branches and the Bureau of the Public Debt. Information on the form is submitted by the bond purchaser to enable the Issuing Agent to complete the bond registration.
- 2. Indicate how, by whom, and for what purpose the information is to be used.** Information is requested to support request for issue. Without the information, the transaction cannot be completed.
- 3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology. What consideration is given to use information technology to reduce burden?**

Public Debt has been a leader in e-Gov, providing the public with options for conducting financial transactions online for several years. To provide our customers additional options for submitting information electronically, we are taking the following steps: a technical project team is exploring options (such as pay.gov) and will select the mechanism(s)/infrastructure needed; concurrently, reengineering of business processes (and forms) is being conducted as the result of a reorganization of our major business lines.

4. **Describe efforts to identify duplication. Why can't any similar information already available be used or modified for use for the purposes described in item 2 above?** Duplicate information is not requested.
5. **If the collection of information impacts small business or other small entities describe any methods used to minimize burden?** This collection of information does not impact small business or other small entities.

8. **What effort was made to notify the general public about this collection of information?** The Bureau's notice was published in the Federal Register on February 19, 2009, Page 7745. No comments were received.
9. **What decision was made to provide any payment or gift to respondents, other than reenumeration of contractors or grantees?** N/A
10. **What assurance of confidentiality was provided to respondents and what was the basis for the assurance in statute, regulations, or agency policy?** In accordance with the Privacy Act of 1974, information furnished by the public is assured confidentiality.
11. **What justification is there for questions of a sensitive nature?** There are no questions of a sensitive nature.
12. **What is the estimated hour burden of this collection of information?** The average time needed is 5 minutes per response multiplied by the estimated number of responses (10,000,000) reflects the total burden of 830,000 hours.

13. **What is the estimated total annual cost burden to respondents or recordkeepers resulting from this collection of information?** Estimated cost burden to respondents is not available.
14. **What is the annualized cost to the Federal Government?** The following factors were used to estimate the annual burden to this agency:
- a. Printing cost - estimated number of forms printed annually, multiplied by the unit cost of the forms.
 - b. Case processing cost - estimated number of forms completed, multiplied by a percentage of the unit cost of processing.
 - c. Forms management cost - salary cost of forms management personnel.
