You are a 27-year old permanent resident married to a U.S. citizen and want to become a U.S. citizen. You want to find out if you are eligible to apply for naturalization.

You are a U.S. citizen who is ready to file Form I-130 to petition for your spouse. You want to find out what color ink to use when filling out a form.

3. Question:

You are a U.S. citizen who wants to bring your fiancé(e) and his/her 12 year-old child to the United States to get married. They both presently live in Kenya. You would like to bring him/her here to get married. You also want to bring your fiancé(e)’s child to the United States to live. What do you need to do?

4. Question:

You are from Bosnia and have been given refugee status in the United States. You want information on whether or not you can travel back to your home country (Bosnia) now that you are refugee here in the United States.

5. Question:

You have filed a petition for a relative that is pending at the Service Center. The beneficiary (your relative) needs to take a medical examination for USCIS to continue processing the application. You want to find a certified civil surgeon in your area (assume you live in Arlington, Virginia, and your area code is 22201).

6. Question:

You submitted an N-400 application for Naturalization and you are in the U.S Army. You are currently overseas on active duty. You want to know where to go to get your fingerprints taken.

You are living in the United States after having been granted refugee status. You submitted an application for a Refugee Travel Document (I-131) so that you can travel abroad. You want to know how long the Refugee Travel Document will be valid after it is issued and whether it can be extended.
