<p>A. Lawful Performance, Operating Authority, and Insurance: All services shall be performed in accordance with applicable Federal and State regulations. Carriers, brokers, freight forwarders, shipping agents or other transportation providers generally referred to as the transportation service provider (TSP) shall possess legal operating authority for the services they offer to DOD as well as public liability insurance, bonds and other surety required by Federal and State regulatory agencies and the Military Freight Traffic Rules and shall maintain their legal authority and the required surety until the completion of the transportation of any shipment accepted for movement by the TSP. If after filing this tender the TSP's operating authority or surety is canceled or changed, then the TSP must notify SDDC within 24 hours and refuses any DOD shipment offered the TSP. The TSP shall ensure the carrier transporting any shipment must comply with all applicable laws and regulations and this tender and the carrier has the necessary legal operating authority and required surety. The TSP by submitting this tender represent(s) and certifies that, as the date filed, the information is correct, they have the legal authority to provide the services offered and the TSP is not disqualified, disbarred or suspended from receiving or performing Federal or DOD procurements or transporting government freight. The TSP will not use any carrier, agent or driver that is disbarred, suspended from procurements or disqualified or in nonuse status from handling DOD cargo to transport DOD freight.</p> <p>B. Payment:</p> <ol style="list-style-type: none"> 1. The DOD shipper is only obligated to pay for services ordered and actually performed. 2. A condition for participating in the procurement of DOD transportation, a TSP must use the DOD's approved electronic payment system. 3. The TSP shall invoice for payment only after delivery is completed, unless the TSP is a railroad or a direct air carrier, and only for services ordered and actually performed. <p>C. References: Where reference is made on this tender to an item, tender, tariff, or classification, the reference shall be construed to include supplements, amendments, or reissues of that item, tender, tariff, or classification, unless otherwise specified in this tender.</p> <p>D. Rates: 49 U.S.C. §§ 10721, 13712 and 15504 rates and FAR contracts schedules of rates and charges:</p> <ol style="list-style-type: none"> 1. By filing this tender the TSP is certifying that its offered rates are fair and reasonable and equal to or less than the rates it offers the general public or commercial customers for the same or similar service in accordance with 49 U.S.C. §§ 10721, 13712 & 15504. 2. If the tender rates are found to be greater than those offered the public or commercial customers for the same or similar service, then the Government will pay the lower applicable public or commercial rate. <p>E.
