34 Operator Characteristics	Add "In what year did the operator begin to operate any farm?"
34 Operator Characteristics	Add a question to determine if operator 2 or 3 is the spouse of the principal operator.
Energy	Add questions asking about presence of on farm renewable energy systems, lease of wind rights, and liquid fuel production
