Attachment C. Changes to ED Facts Data Set From 2006-07 to 2007-08

Introduction

This attachment contains a detailed description of the proposed changes to ED Facts from the 2006-07 to the 2007-08 reporting year. For a full listing of all data groups and data categories proposed for collection through ED Facts for school year 2007-08 (including data groups and data categories with no proposed changes) refer to Attachment B of this OMB clearance package.

This attachment is organized to provide a description of the significant changes to ED Facts proposed for the 2007-08 reporting year by providing detailed discussions of changes to first the data groups and second the data categories for 2007-08. (Some non-substantive, technical, and editorial corrections are not included in this attachment.) Each section starts with an overall summary followed by a series of tables and summary text that are organized by the type of proposed change.

Changes to ED Facts Data Groups for 2007-08

- **New Data Groups** – This table lists the new data groups. The table includes the name, identification number, definition, permitted values/format, reporting level, and steward of the new data groups and the name of the section of attachment B where the rest of the information on the data group may be found. This section is presented in order by data group ID.
- **Dropped Data Groups** – A small number of data groups are proposed for removal for the 2007-08 ED Facts data cycle. This list is presented by data group ID.
- **Name Changes** – This table lists the existing data groups where the name of the data group will be changed for 2007-08. Since the data group number will remain unchanged, the list is presented in order by data group number and includes both the old and the new name of the data group.
- **Changes to Data Groups** – There are a number of proposed changes to the ED Facts data set for 2007-08 that revise the definition, category sets, collection level, and/or permitted values/format used within specific data groups. In this section, there is a separate page for each revised data group presented in alphabetical order by data group name. Each page shows the data group as collected for 2006-07 and the proposed changes for 2007-08. Data group changes that do not affect state submissions (e.g., editorial changes) are not included here.

Changes to ED Facts Data Categories for 2007-08

- **New Data Categories** – This table lists all of the proposed new data categories for 2007-08. The table includes the definition, the permitted values, comments, and the ED Facts data groups that use the new category. This list is presented in alphabetical order by name of the data category.
- **Dropped Data Categories** – A small number of data categories are proposed for removal for the 2007-08 ED Facts data cycle. This list is provided in alphabetical order.
- **Data Category Changes** – For the 2007-08 reporting year, there are a number of proposed changes to definition and/or permitted values used with the data categories. Within this section, there is a page for each data category with a change. The page shows the data category as used for 2006-07 as well as all of the changes proposed for 2007-08. These pages are organized in alphabetical order by name of the data category. Data category changes that do not affect state submissions (e.g., editorial changes) are not included here.

Changes to ED Facts Data Groups for 2007-08

Summary of Data Group Changes From 2006-07 to 2007-08

Overall, there were 187 data groups approved for the 2006-07 data collection.¹ As shown in the table below, the number of data groups changed to 185 for 2007-08. These figures include all data groups – regular data groups (collected through ESS) as well as the survey data groups and the data groups associated with the on-line data collection.

New Data Groups

Some of the data groups classified as new are actually spinoffs from existing data groups. For instance, for 2007-08 the Title I Participation Table was split into two data groups. One collects data about all students participating in Title I programs. The second collects data only from LEAs with Title I, Part A SWP or TAS programs. Finally, in addition to changes in the overall number of data groups between 2006-07 and 2007-08, the ED Facts team made changes to the level at which data groups are collected. Although the school level was added for two data groups, overall there was reduced reporting burden from eliminating a reporting level. For three data groups, the school-level data collection was eliminated. The LEA level was eliminated for eight data groups and added for one data group. The state level was eliminated for two data groups and added for one. Finally, the level was changed from LEA to SEA for another four data groups.

The following table shows the proposed new data groups for the 2007-08 ED Facts reporting cycle. For each new data group, we provide the ID, name, definition, section, permitted values/format, data category sets, reporting level, and data steward.

¹ The 2006-07 OMB package indicated that the total number of data groups was 186 when in fact the total was 185. In addition, two data groups were added as the result of the September 20, 2006, errata, thereby increasing the total number of 2006-07 data groups from 185 to 187.

The remaining two-thirds are in C-2 and C-3. The left side of the page shows the data group as approved for the 2006-07 *ED Facts* reporting cycle. The right side of the page shows the proposed data group for 2007-08. There are check boxes to the right of each element of the data group – Section, Definition, Permitted Value or Format, Category Set, Totals, and Reporting Levels. All changes are marked with these check boxes. Additional notes regarding the change(s) are provided in the far right column of each page.
