The attached Form RRB-1001 is being provided to give you an opportunity to claim a tax treaty exemption. Claiming a tax treaty exemption makes you eligible for reduced tax withholding under any tax treaty in effect between the United States and your country of legal residence.

If you have not previously claimed a tax treaty exemption, your country of legal residence may now have a tax treaty with the United States. If you have previously claimed a tax treaty exemption, your exemption will soon expire. The United States Internal Revenue Service (IRS) requires tax treaty exemption claims be renewed on a periodic basis. In addition, the IRS now requires a United States taxpayer identifying number from all individuals claiming a tax treaty exemption.

Read the enclosed Form TB-125 for additional information about claiming a tax treaty exemption and about United States taxpayer identifying numbers. Complete and return the Form RRB-1001 attached below in the envelope provided (we suggest you use air mail) if you wish to claim a tax treaty exemption. To do so, you must:

- (1) Furnish a United States taxpayer identifying number in item B,
- (2) Enter your claimed country of legal residence in item 2,
- (3) Check the tax treaty exemption claim box "YES" in item 3, and
- (4) Sign and date the form in item 5.

You do not need to return this form if you have completed one according to the above instructions within the last 45 days, or if you do not wish to claim a tax treaty exemption.
