- SHRINK and DUMP:** Report the projected shrinkage and dump amount, in hundredweight or as a percent of the total production, for the current season's potato crop from **March 1** through **April 1**.
- SALES:** Only report sales of potatoes grown by you. Exclude potatoes purchased from other growers. If you did not sell any of your potatoes last month, enter "none".
