Web user survey for specific EIA product: This Week in Petroleum. (DOE-887(87))

PURPOSE:

The purpose of this web survey is to collect customer feedback and suggestions on specific EIA web products. The first survey we plan to conduct will be on our very popular “This Week in Petroleum” product. EIA wants to solicit feedback from customers who use our products to help us make decisions about upgrading, consolidating, and modifying our web products.

DESCRIPTION OF RESPONDENTS:

Respondents will be users and potential users of EIA products on the web. The web survey will target only persons who visit a specific product during the time the survey is live. Customers to the EIA include policy-makers, business and financial markets, the energy industry and other businesses, the media, teachers and students, and private citizens.

Based on past responses to EIA web customer surveys, responses will be from individuals, the private sector, and Federal, state, and local governments, although the exact shares of response from each group are not predictable in advance. The survey will be posted on the EIA website on or shortly after July 19, 2012, and remain active until the target 1000 responses have been acquired.
