The Participant also agrees as part of this contract to implement on such designated acreage the Conservation Plan or Forest Stewardship Plan for energy crop production developed for such acreage and approved by the CCC and the Participant. Additionally, the Participant and CCC agree to comply with the terms and conditions contained in this Contract, including the Appendix to this Contract, entitled Appendix to BCAP-3 Biomass Crop Assistance Contract (referred to as "Appendix"). By signing below, the Participant acknowledges that a copy of the Appendix has been provided to such person. Such person also agrees to pay such liquidated damages in an amount specified in the Appendix if the Participant removes or modifies acres after contract approval. The terms and conditions of this contract are contained in Forms BCAP-2 Worksheet, this BCAP-3 Contract, and the BCAP-3 Appendix and any addendum thereto.
