

NBS PROXY EXPERIMENT PROTOCOL: PROXY SCREENER

NOTE: This screener is a pre-requisite for the actual survey, which is conducted immediately after. The Privacy Act and Paperwork Reduction Act statements are provided on the actual surveys.

THREE ITEM COGNITIVE ASSESSMENT TO SELECT PROXY

The three item cognitive assessment is the current method used by NBS to determine need for a proxy. The three questions are asked at the beginning of the interview before any substantive questions are asked. If respondents are unable to restate accurately any description after two attempts, we ask if someone else could answer questions on their behalf. All three questions must be answered accurately for the sample person to be eligible for the interview. These items have been included in all previous NBS administrations. The complete round 4 NBS questionnaire is provided in as a separate file.

A subset of respondents will not receive the three item assessment, but will be randomly assigned to the treatment condition (string of missing responses)--if they answer "don't know" or "refused" to 6 or more pre-specified items at the beginning of the survey, they will be considered ineligible to complete the survey and a proxy respondent will be sought.

TICS

In past administrations, sample members who did not respond accurately to the cognitive assessment items were asked immediately if someone else could answer the study questions. For the experiment, we will administer the Telephone Interview of Cognitive Status (TICS) (a standardized test of cognitive functioning) to a random subset of respondents in the treatment and control group and ask respondents 4 questions from the NBS, prior to requesting a proxy or continuing with the interview.

TICS1 Please tell me your full name.

TICS2 What is today's date?

TICS3 Where are you right now?

TICS4 Please count backward from 20 to 1.

TICS5 I am going to read you a list of 10 words. Please listen carefully and try to remember them. When I am done, tell me as many of the words as you can, in any order. The words are cabin, pipe, elephant, chest, silk, theater, watch, whip, pillow, giant. Now tell me all of the words you can remember.

TICS6 I would like you to take the number 100 and subtract 7. Now keep subtracting 7 from the answer until I tell you to stop.

TICS7 What do people usually use to cut paper?

TICS8 How many things are in a dozen?

What do you call the prickly green plant that lives in the desert?

What animal does wool come from?

TICS8 Please repeat this after me: "No its, ands, or buts." Now please repeat this after me: "Methodist Episcopal"

TICS9 Who is the President of the United States right now?

Who is the Vice-President?

TICS10 With your finger, tap five times on the part of the speak into.

TICS11 I am going to say a word and I want you to give me it's opposite. For example, if I said "hot", you would say "cold". What is the opposite of "west"?

What is the opposite of "generous?"

NBS ITEMS ASKED BEFORE SCREEN-OUT

Respondents who are screened out by either method will be asked seven items from the NBS before a proxy is requested. Respondents who are not screened out will receive these items later in the survey.

J1. Now, I'm going to ask you about different types of health insurance coverage {you/NAME} might have.

Are you currently covered by Medicare?

PROBE: Medicare is health insurance coverage provided nationally to certain disabled people under age 65, including Social Security Disability Insurance beneficiaries that have been receiving benefits for more than 24 months.

IDENTIFYING A PROXY

Once these items are completed, respondents who screen out will be directed to item A80 and receive the following script:

PROBE: This might be someone who lives with you, a friend, or someone like a social worker or case worker.
