A. Justification

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

This collection of information requires warehouse proprietors, carriers, Foreign Trade Zone operators and others to prepare a CBP Form 6043 (Delivery Ticket) to cover the receipt of the merchandise and its transport from the custody of the arriving carrier. The transferring parties and the bonded carrier are required to jointly determine the quantity and condition of the goods or articles so delivered to the warehouse. Any discrepancy between the quantity and condition of the goods and that reported on CBP Form 6043 will be reported to the port director within two working days of the agreement. This collection of information is required by 19 USC 1551a, and by 19 CFR Part 125.

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

The information is to be used by CBP officers to document transfers of imported merchandise between parties.

- 3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. The information on the Delivery Ticket, Form 6043 can currently be transmitted electronically through the Automated Manifest System (AMS). It is estimated that approximately 20 percent are filed through AMS.

This information is not duplicated in any other place or any other form.

This information collection does not have an impact on small businesses or other small entities.

Without this information, CBP would not be able to document transfers of imported merchandise between parties.

This information is collected in a manner consistent with the guidelines of 5 CFR 1320.5(d)(2).

Public comments were solicited through two Federal Register notices published on October 5, 2009 (Volume 74, Page 51163) and on December 7, 2009 (Volume 74, Page 64092). No comments were received.

There is no offer of a monetary or material value for this information collection.

Public Cost

The estimated cost to the respondents is \$1,848,000. This is based on the estimated burden hours (66,000) multiplied (x) the hourly rate (\$28.00).

- 13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information.**

There are no record keeping, capital, start-up or maintenance costs associated with this information collection.

- 14. Provide estimates of annualized cost to the Federal Government. The estimated annual cost to the Federal Government associated with the review of these records is **\$1,394,400**. This is based on the number of responses (200,000) that must be reviewed (x) the time to review and process each response (.166 hours) = 33,200 hours (x) the average hourly rate (\$42.00) = 1,394,400.

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection
