Pursuant to your request of this date, we are enclosing Certified Tomato Repackers Certificate No. _____ for the 20XX-20XX season. **Only previously inspected** tomatoes resorted, regraded and repacked by a handler who has been designated as a "Certified Tomato Repacker" by the Committee are exempt from the tomato grade classifications except for minimum grades; the size classifications except that tomatoes shall be over 2-9/32 inches in diameter; and the container weight requirements; if such tomatoes comply with the inspection requirements.
