MSSICS 013.007 Financial Institution Accounts (RFIA)

A. INTRODUCTION

These screens record information such as: the type of financial institution account the account number, the name and address of the financial institution, the value of the account for particular periods, and whether the account is co-owned, earns interest and/or is set aside for burial. These screens are available for the claimant, eligible spouse and/or deemsors,

B. AUTOMATED SYSTEMS FEATURES

When the responses on this screen indicate the presence of potentially countable interest income, the system propagates certain information to the Income Menu (IMEN) and Interest Income (IINT) screens.

When the account earns interest and:

is not set aside for burial, -or-

is set aside for burial, but the interest does not remain in the burial fund, -or-

is set aside for burial, the interest remains in the fund, but part or all of the burial funds are determined to be a countable resource,

the system propagates the following information.

On the Income Menu (IMEN) screen a "Y" is propagated to INTEREST.

On the Interest Income (IINT) screen:

- SOURCE is propagated from INSTITUTION NAME [6-M],
- ID is propagated from ACCOUNT NUMBER [5-O],
- ADDRESS is propagated from ADDRESS [7-O] and
- TYPE RECEIVED is propagated from TYPE OF ACCOUNT [2-M].

The system only propagates the information the first time you transmit a Financial Institution Accounts (RFIA) screen which satisfies the above conditions. Only one iteration will be propagated. If you later change any of the information you have entered you must enter the changes to the Income screens.

[25-M] RESOURCE EARNS INTEREST (Y/N): P

This is pre-filled with the response to EARNS INTEREST [4-M]. If you change the value in this field, the system will change the value in the EARNS INTEREST field [4-M] to correspond.

[26-C] IF RESOURCE EARNS INTEREST, INTEREST REMAINS IN FUND (Y/N): X

Enter a "Y" or "N" only if RESOURCE EARNS INTEREST [25-M] = Y
