Who must comply?	Air carriers and aircraft operators operating flights within the United States must submit monthly reports on screened cargo carried on passenger aircraft.	
What is this collection about?	This information collection requires an air carrier or aircraft operator to collect, report, and submit information on the volume of cargo screened for transport on passenger aircraft.	
Where do I find the requirements for this information?	The cargo reporting requirements can be found in the Aircraft Operator Screening Standard Security Program for Aircraft Operators or the Model Security Program for Air Carriers.	
When must information be submitted to the TSA?	The information must be reported to TSA on a monthly basis and is due no later than the 10th day of the month following the cargo screening date (e.g., February data must be reported by March 10th).	
How is the information submitted?	The information must be submitted using the Cargo Reporting Tool at https://fas.tsa.dhs.gov/. Whenever the Cargo Reporting Tool is not available, an Air Carrier or Aircraft Operator may submit the report template in an electronic format to <a href="mailto:Cargoreporting@dhs.gov">Cargoreporting@dhs.gov</a>	
	Each air carrier or aircraft operator should use the following e-mail subject header when submitting reports:

What happens when complete information is received?	Once TSA receives all required screened cargo data, TSA must submit a report, on a quarterly basis, to Congress detailing the volume of screened cargo transported on passenger aircraft.
