Sections 4 & 5 are the detail questions section for completed and attempted sexual assault: Section 4 asks about first ever and Section 5 asks about most recent. The interviewer will ask questions from sections 4 & 5 (as appropriate, based on the responses to the screening questions from section 3). We are going to ask the subset of detail

questions about the first and most recent incidents (presuming there were multiple events reported) of the remaining **less "severe"** experiences reported (e.g., unwanted touching and noncontact sexual situations). For **Unwanted Sex** and **Attempted Unwanted Sex** we also need to have some coding that will take into account if the respondent reports experiencing only 1 type of sex (e.g., only vaginal, anal, or oral), then the follow-up detail questions should refer to that specific type of sex. Similarly, if more than 1 type is reported, then the follow-up questions should refer to the unwanted incident as 'sex.' For example:

CONDITIONAL: If more than 1 type of unwanted sex reported in Section 3,

DUMMY = 'sex'; else if only 1 type of unwanted sex reported:

DUMMY: vaginal sex oral sex anal sex

*If DUMMY* = 'sex' then the first question (Q4.1) will determine which type(s) of SV occurred during the incident.

### Section 4: Severe Detail Questions - FIRST EXPERIENCE

Up to this point, I have been asking you some basic questions about your various experiences of unwanted sex. Now, I want to ask some more detailed questions about your **first** experience of unwanted DUMMY. Some people may find these questions upsetting.
