- Broadband Platform: the technology platform of the service offering (e.g., fiber to the home, cable, DSL, WiMax, 3G mobile wireless).
- Downlink Speed: the advertised speed of the downstream connection (should be clearly labeled as either Mbps or Kbps).
- Uplink Speed: the advertised speed of the upstream connection (should be clearly labeled as either Mbps or Kbps).
- Price per month: the price per month of the service.
- Geographic Scope: denote the geographic scope in which this service offering is available (*e.g.* nationwide, southeastern US (FL, GA, SC), California, New York metro area).

## **Coverage and Subscription Data**
