

**Supporting Statement
Customs-Trade Partnership against Terrorism (C-TPAT)

A. Justification

The Customs-Trade Partnership Against Terrorism (C-TPAT) Program is designed to prevent smugglers from utilizing commercial conveyances for their commodities, and to provide expedited processing to participants in this Program at certain, high-risk locations by prescreening participants. The C-TPAT Program applies to air, land, and sea. This program was mandated by the SAFE Port Act (P.L.109-347).

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

The information collected on drivers, and sea and air carriers is to be used by CBP officers to assist in the release of merchandise at certain high-risk locations to enhance CBP ability to assess the threat of certain commercial transactions more effectively. Respondents provide this information to CBP in order to participate in the C-TPAT Program and receive expedited processing at border locations. The information is submitted through an on-line C-TPAT application.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. This information is not duplicated in any other place or any other form.

This information collection does not have an impact on small businesses or other small entities.

Failure to collect this information would result in CBP to discontinuing the C-TPAT program which would have a negative impact on the trade community by increasing the processing time at ports of entries.

- requiring respondents to report information to the agency more often than quarterly;
- requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;
- requiring respondents to submit more than an original and two copies of any document;
- requiring respondents to retain records, other than health, medical, government contract, grant-in-aid, or tax records for more than three years;
- in connection with a statistical survey, that is not designed to produce valid and reliable results that can be generalized to the universe of study;
- requiring the use of statistical data classification that has not been reviewed and approved by OMB;
- that includes a pledge of confidentiality that is not supported by authority established in statute or regulation, that is not supported by disclosure and data security policies that are consistent with the pledge, or which unnecessarily impedes sharing of data with other agencies for compatible confidential use; or
- requiring respondents to submit proprietary trade secrets, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.

This information is collected in a manner consistent with the guidelines of 5 CFR

1320.5(d)(2).

Public comments were solicited through two Federal Register notices published on February 10, 2010 (Volume 75, Page 6678) and on April 15, 2010 (Volume 75, Page 19654). No comments were received.

Public Cost

The estimated cost to the respondents is \$910,000. This is based on the estimated burden hours (32,500) multiplied (x) hourly rate (\$28.00).

There are no record keeping, capital, start-up or maintenance costs associated with this information collection.

The estimated annual cost to the Federal Government associated with the review of these records is **\$682,500**. This is based on the number of responses (6,500) that must be reviewed (x) the time to review and process each response (2.5 hours) = 16,250 hours (x) the average hourly rate (\$42.00) = \$682,500.

15. Explain the reasons for any program changes or adjustments reported in Items 12 or 13 of this Statement.

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection

This information collection will not be published for statistical purposes.
