Supporting Statement Information Relating to Beneficiary of Private Bill (Form G-79A) OMB No. 1653 - 0026

A. Justification:

1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.

Section 212 of the Immigration and Nationality Act (INA) identifies classes of alien not eligible for admission into the United States. The information obtained from this information collection is used to prepare a report to the appropriate Congressional Committee (Senate or House of Representatives) and advise whether a person for whom a Private Bill has been introduced is or is not in violation of Section 212 of the INA.

2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

This form is used by ICE to obtain information from beneficiaries and/or interested parties in Private Bill cases when requested to report by the Committee on the Judiciary.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.

The use of this form provides the most efficient means for collecting and processing the required data. In this case ICE does not employ the use of information technology in collecting and processing information. Currently the ICE does not have the automated capability in place to accept electronic submission of applications.

This information is not collected in any form, and therefore is not duplicated elsewhere.

If the information collection is not approved, ICE has no means by which to report to Congress the required information relative to Section 212 of the INA and the beneficiary of a Private Bill.

 - requiring respondents to submit proprietary trade secret, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.

The special circumstances contained in item 7 of the Supporting Statement are not applicable to this information collection.

On January 19, 2010, USICE published a notice in the Federal Register at 75 FR 2881, soliciting public review and comment for a 60 day period on the proposed extension of this information collection. USICE received no comments during this period. On March 31, 2010 USICE published a follow up notice in the Federal Register at 75 FR 16158 soliciting public review and comment for an additional 30 day period. USICE has received one (1) comment during that 30 day period and provided a response to the commenter.

9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.

ICE does not provide payments or gifts to respondents in exchange for a benefit sought.

10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation, or agency policy.

There are no assurances of confidentiality provided to the respondents of this information collection.

Annual Reporting Burden

Total annual reporting burden hours are 100. This figure was derived by multiplying the number of respondents (100) x frequency of response (1) x hours per response (1.0).

Public Cost

The estimated annual public cost is \$ 1,000. This estimate is based on the number of respondents (100) x number of responses (1) x hours per response (1.0) x average hourly rate (\$10).
