The HSLs:09 parent address update screen will be modeled after the one used for ELS:2002, with additional fields added to list the name of the school the sampled student will attend in the 2010-2011 school year and the city and state of that school. The HSLs:09 version has not yet been programmed, but a screen shot of its ELS:2002 counterpart is provided for reference.
