All personnel with access to individual data will be required to sign a confidentiality agreement and an affidavit of nondisclosure. Anyone who violates the confidentiality provisions of the act when using the data shall be found guilty of a **Class E felony** and can be **imprisoned up to 5 years**, and/or **fined up to \$250,000**.





- Oversee the preparation of a list of students enrolled at your institution. This list will be used to draw a sample of students from your institution for participation in NPSAS:12. Beginning in the spring of 2012, sampled students will be asked to complete a questionnaire via the Internet.
- Complete a separate web-based program (or prepare a data file) providing institution record information on such things as enrollment status, demographic characteristics, and financial assistance provided for the sampled students.

The initial due date for providing your student enrollment list is (Date). (Your deadline date is tailored to your institution's term structure.) Complete specifications for compiling this list and uploading it to the secure website are provided online, at the NPSAS school website.
