Incorporating these standards by reference into FERC's regulations is intended to benefit wholesale electric customers by streamlining utility business practices and transactional processes; OASIS procedures and by adopting a formal ongoing process for reviewing and upgrading FERC's OASIS standards &amp; other electric industry business practices that would benefit from implementing generic industry standards</p>
