<u>Change 1</u>: We are adding examples in Section 4 (Information About the Child's Medical Records), part E., page 6, and changing the order of the examples for a more logical sequence.

Old Language:

<u>Justification 2</u>: The Women, Infant and Children Program is much more commonly known as "WIC" and as a child welfare program. Therefore, it is clearer to use only the acronym and couple it with child welfare. Early Intervention Services replaces the full name of the WIC program and adds an important source of information to the form.

Change 3: We are changing the language in Section 8 (EDUCATION), part A, page 9.

Old Language:

What is the child's **current grade** in school or the **highest grade** completed?

New Language: Is the child currently enrolled in any school? check box, Yes, Grade_____ checkbox, No, too young

<u>Justification 3</u>: We are clarifying both the question and the possible responses to eliminate confusion.

Change 4: We are changing the language in Section 8 (EDUCATION), part B, page 9.

Old Language:

Is the child currently attending school (*other than summer school*)?" YES NO If "NO", explain why the child is not attending school"

New Language:

Other Reason the child is not enrolled in school.

Justification 4: This further clarifies and streamlines the education questions consistent with part A. under this section.

<u>Change 5:</u> We are revising Section 8 (EDUCATION) part C, page 9, by adding "/language" to "Is the child in speech therapy?" and NAME OF SPEECH THERAPIST.

Is the child in speech therapy? YES NO If "YES", and different from above, give: NAME OF SPEECH THERAPIST

New Language:

Is the child in speech/language therapy?
If "Yes", and different from above, give:

We are revising the Education and Work: More About Education History Section by removing the question What is the highest grade that Frank Doe completed?

Change 9

We are changing the language in the Medical History: Additional Sources of Testing or Examination Section by adding Early Intervention Services to options to add "Early Intervention Services".
