Dear Ms. Dortch:

On July 22, 2010, the FCC met with broadband internet service providers, its fixed broadband performance contractor, and the New America Foundation to discuss technical issues related to the Commission's trial for testing and measurement of fixed broadband performance.<sup>1</sup> A full list of the meeting attendees is attached.

Discussions focused on issues related to ISPs' ability to support the testing and measurement methodologies of the Commission's trial. In particular, ISPs discussed ways that information gathered from subscribers could be confirmed against ISP providers' records to improve the data quality of the trial. Participants also discussed ways to satisfy privacy and other legal requirements to facilitate ISPs contributions.

The group discussed plans for a follow-up meeting to be held in the next month when participants would share thoughts on progress of the testing trial.
