**Broiler-type:** relates to chicks hatched for placement as commercial broilers for meat production, plus chicks hatched

for Broiler-Type hatching egg supply flocks.

**Egg-type:** relates to chicks hatched to supply replacement layers for market egg production, and chicks hatched for Egg-Type hatching egg supply flocks. Include males destroyed.

**Eggs in**

**Incubators:** Report total eggs in incubators and hatchers on the first of each month, classified between Broiler-Type

and Egg-type. Normally all eggs set in incubators in the previous 20 days will remain in incubators/hatchers on the first of the month.

**Chicks**

**Hatched:** Report total hatched during month, classified between Broiler-Type and Egg-Type. Include all chicks which were destroyed in the total chicks hatched.
