# Census Household Form – Paper Protocol

Draft – 15 December 2011

# APPROACH:

- HAVE PARTICIPANT COMPLETE THE ENTIRE FORM, REMINDING THEM TO THINK ALOUD PERIODICALLY. PARTICIPANTS CAN READ QUESTIONS ALOUD OR SILENTLY.
- NOTE ANY PROBLEMS OR CONFUSION PARTICIPANT HAS WHEN ANSWERING THESE ITEMS, PROBING FOR CLARIFICATION AS NECESSARY.
- DO NOT ASK ANY SCRIPTED PROBES UNTIL THE END.
- PAY SPECIAL ATTENTION TO WHETHER SURVEY QUESTIONS "WORK" FOR MOVERS, SEASONAL, AND CUSTODY CASES.
- NOTE WHETHER PARTICIPANT COUNTS THE SAME PERSON IN MULTIPLE QUESTIONS

# ONLINE FORM:

- NOTE WHETHER PARTICIPANT COMMENTS ABOUT ONLINE FORM
- IF R DECIDES AT THIS POINT THAT THEY WOULD FILL OUT THE FORM ON-LINE, PROBE:
  - Why do you think you should respond online?
  - Thanks. I understand the reasons that you think you should respond online. But just for today, let's assume that you can't go on-line and you've decided to fill out the paper form instead.

#### **RETROSPECTIVE PROBING:**

- FIRST, IF THEY HAD ANY NOTICEABLE PROBLEMS OR CONFUSION THAT THEY MENTIONED WHILE ANSWERING THESE QUESTIONS, GO OVER THESE FIRST.
- PROBE BRIEFLY ABOUT THEIR PROBLEMS WITH THE DEMOGRAPHIC QUESTIONS, BUT ONLY IF THEY HAVE EXPRESSED CONCERN OR DIFFICULTY. THIS IS ONLY TO NOTE THEIR CONCERNS

## Who should use this paper form?

- Anyone who, on January 15, 2012, was living or staying at the address printed on this form.
- Anyone who lives and sleeps most of the time at the address printed on this form.
- Anyone whose entire household moved into this address <u>on</u> or <u>before</u> January 15, 2012.

## Who should respond online?

- Anyone whose entire household moved into this address printed on this form *after* January 15, 2012.
- Anyone who needs to report that the address printed on this form was vacant on January 15, 2012.
- Anyone who needs to report that the address printed on this form is a seasonal home.
- Anyone who has more than two places to live.
- 1. What was the first thing you saw on this page? Where did you start to read? How much of these instructions did you read?
- 2. What is the first set of instructions telling you? Who is supposed to fill out this form?
- 3. In the first bullet, what does "living or staying" mean in this context?

- 11. Question 1 uses two phrases: "live and sleep" and "living or staying". Do they sound like they mean the same thing here or do they mean something different? Please tell me how they are the same or different.

- 13. IF NECESSARY: I noticed that you changed your answer to Question 1. Can you tell me what you were thinking when you did that?

- 72. What does "living and sleeping here" mean to you? Does it mean the same thing or something different?
- 73. Was there anything in these questions that you found sensitive or uncomfortable to answer?
- 74. Was there any information for yourself or others that you would be hesitant to provide on the census form?
- 75. Aside from the things we've talked about, were there any questions or instructions that you find confusing or difficult to answer?
- 76. Did you find parts of the interview repetitive? If so, what parts?
- 78. If you were going to answer your census questionnaire on your own, without an interviewer, how would you prefer to do it:On a smartphone?

On a tablet? On a laptop or desktop? On a paper form?

Why? If smartphone or tablet, what kind?

79. If you don't answer the census on your own, an interviewer might be sent to your home to get your census information. How would you feel about the interviewer using a smartphone to do the interview? A Tablet, like an iPad? How about a laptop computer? How about a paper form? Which do you prefer and why?
