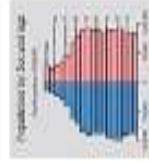

History

The United States acquired the area of California from Mexico in 1848, with generally the same boundary as the present state. The area of California was never organized as a territory, but was administered from 1848 to statehood by a federal military authority. California was admitted to the Union on September 9, 1850, as the 31st state.

Census data for California are available beginning with the 1850 census; however, the data for 1850 are incomplete because the questionnaires from Contra Costa and Santa Clara Counties were lost and those for San Francisco County were destroyed by fire. Some missing 1850 data have been supplanted by information obtained from a state census in 1852.

Data for the legally established state of California are available beginning with the 1850 census.

American Indian Areas

California has 108 federally recognized American Indian areas. There are 104 reservations; 28 with off-reservation trust land in the state. Two are trustlands only. The remaining two are tribal designated statistical areas (TDSAs).

Metropolitan and Micropolitan Statistical Areas and Related Statistical Areas

California has 26 metropolitan statistical areas, 9 micropolitan statistical areas, 4 combined statistical areas, and 4 metropolitan divisions.

Counties

There are 58 counties in California. The city and county of San Francisco have consolidated functions and is classified as a municipal government that operates primarily as a city. All other counties are each governed by a board of supervisors.

County Subdivisions

There are 397 county subdivisions in California. They are all census county divisions (CCDs), which are delineated for statistical purposes, have no legal function, and are not governmental units. CCDs were first established in California for the 1990 census. Prior to 1990, the minor civil divisions used in the census included election precincts, judicial townships, supervisor's districts, and one American Indian reservation (in 1870).

Places

California has 1,523 places; 480 incorporated places and 1,043 census designated places (CDPs). The incorporated places consist of 459 cities and 21 towns. In California an incorporated place can legally exist only in a single county.

Census Tracts/Block Groups/Blocks

California has 8,057 census tracts, 23,212 block groups, and 710,145 blocks.

Congressional Districts

For the 111th Congress (January 2009-January 2011), California has 53 congressional districts. Beginning with the 113th Congress (January 2013-January 2015), California will continue to have 53 congressional districts as a result of the reapportionment based on the 2010 census.

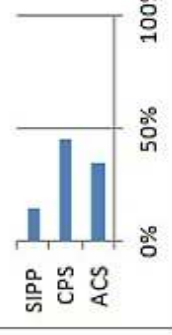

This breaks a string of three years of annual income increases and coincides with the recession that started in December 2007.

What is Census 2010?

The U.S. Census counts every resident in the United States. It is mandated by Article I, Section 2 of the Constitution and takes place every 10 years. The data collected by the decennial census determine the number of seats each state has in the U.S. House of Representatives and is also used to distribute billions in federal funds to local communities.

The 2010 Census represented the most massive participation movement ever witnessed in our country. Approximately 74 percent of the households returned their census forms by mail; the remaining households were counted by census workers walking neighborhoods throughout the United States. National and state population totals from the 2010 Census were released on December 21, 2010. Redistricting data, which include additional state, county and local counts, will be released starting in February 2011.

Why It's Important

Census information affects the numbers of seats your state occupies in the U.S. House of Representatives. And people from many walks of life use census data to advocate for causes, rescue disaster victims, prevent diseases, research markets, locate pools of skilled workers and more.

When you do the math, it's easy to see what an accurate count of residents can do for your community. Better infrastructure. More services. A brighter tomorrow for everyone. In fact, the information the census collects helps to determine how more than \$400 billion dollars of federal funding each year is spent on infrastructure and services like:

- Hospitals
- Job training centers
- Schools
- Senior centers
- Bridges, tunnels and other-public works projects
- Emergency services

How It Benefits Your Community

When you completed the 2010 Census questionnaire or an in-person interview with a census taker, you made a statement about what resources your community needs.

Accurate data reflecting changes in your community are crucial in apportioning seats in the U.S. House of Representatives and deciding how more than \$400 billion per year is allocated for projects like new hospitals and schools.

That's more than \$4 trillion over a 10-year period for things like new roads and schools, and services like job training centers.

The census effect in action

In addition, residents themselves have used census data to support community initiatives involving environmental legislation, quality-of-life issues and consumer advocacy.

• "This data shows that Phillips has a higher number of both elderly and children under the age of 5 within its boundaries." A neighborhood in Minneapolis used census data to push for further examination of the environmental and physiological impact of a proposed energy facility. Each decade, after it tabulates the decennial census, the Census Bureau publishes the center of population. The National Mean Center of Population based on the 2010 Census is near Plato, Mo., an incorporated town in Texas County.

Enumeration

The 1950 census encompassed the continental United States, the territories of Alaska and Hawaii, American Samoa, the Canal Zone, Guam, Puerto Rico, the Virgin Islands of the United States, and some of the smaller island territories.

Americans abroad were enumerated for the first time in 1950. Provisions were made to count members of the armed forces, crews of vessels, and employees of the United States government living in foreign countries, along with any members of their families also abroad. This enumeration was carried out through cooperative arrangements with the departments of Defense and State, the United States Maritime Administration and other federal agencies that took responsibility for distributing and collecting specially designed questionnaires.

Other persons living abroad were to be reported by their families or neighbors in the United States, but the quality of these data was considered to be poor and they were not included in the published statistics.

A new survey on residential financing was conducted as part of the 1950 census. In a separate operation, information was collected on a sample basis from owners of owner-occupied and rental properties and mortgage lenders.

Efforts to Improve Coverage and Completeness

Several procedures were used to improve the accuracy and completeness of the 1950 census, including: improved enumerator training, providing enumerators with detailed street maps of their assigned areas, publishing "Missed Person" forms in local newspapers, and setting a specific night to conduct a special enumeration of persons in hotels, tourist courts, and other places frequented by transients.

For the first time, a post-enumeration survey was instituted as a further check on the accuracy and completeness of the count. The Census Bureau recanvassed a sample of about 3,500 small areas and compared these to the original census listings to identify households that may have been omitted in the original enumeration. In addition, a sample of about 22,000 households was reinterviewed to determine the number of persons likely omitted in the initial count.

Technological Advancement

The Census Bureau began use of the first non-military computer shortly after completing the 1950 enumeration. UNIVAC I (for Universal Automatic Computer), the first of a series, was delivered in 1951, and helped tabulate some of the statistics for the 1954 economic censuses. It weighed 16,000 pounds and used 5,000 vacuum tubes.

Intercensal Activity

In August of 1954, Congress codified the various statutes, including 1929's Fifteenth Census Act, which authorized the decennial and other censuses, as Title 13, US Code. Since then, Title 13 (along with other laws) has been the underlying authority that governs the actions of the Bureau

PURPOSE

The purpose of the Building Permits Survey is to provide national, state, and local statistics on new privately-owned residential construction. The United States Code, Title 13, authorizes this survey provides for voluntary responses, and provides an exception to confidentiality for public records.

COVERAGE

All places issuing building permits for privately-owned residential structures. Over 98 percent of all privately-owned residential buildings constructed are in permit-issuing places.

CONTENT

Data collected include number of buildings, number of housing units, and permit valuation by size of structure.

FREQUENCY

Data on permits issued for new construction are available monthly and annually since 1958; reports of data are for permit-issuing activity taking place during the applicable reference period. Prior to 1958, data were collected by the Bureau of Labor Statistics.

METHODS

A monthly survey of 9,000 selected permit-issuing places; and an annual census of an additional 11,000 permit places that are not in the monthly sample. The monthly sample of permit-issuing places was selected using a stratified systematic sample procedure. All permit places located in selected large metropolitan areas were selected with certainty. The remaining places were stratified by state. Places that exceed a cutoff value, which varies by state, were selected with certainty. Remaining places were sampled at a rate of 1 in 10.

PRODUCTS

New Residential Construction press releases contain the first available permit data and are released on the 6 or about the 12th working day following the reference month. The reports contain the first available preliminary monthly estimates of the number of new housing units authorized. Data are shown by type of structure, at the national level, and by Census Region. All data are placed on the Census website at: www.census.gov/permits.

Revised monthly data are released on or about the 18th working day following the reference month. At that time, monthly estimates are available at the Census Division, state, metropolitan area, county, and permit-issuing-place levels. Public-use computer data files are also available at that time. All data are placed on the website shown above. Estimates in the New Residential Construction press release are not updated on the 18th working day. Any revisions are shown in the next month's release.

USERS

The Conference Board uses the data for developing its index of leading economic indicators. The Federal Reserve Board uses the data to analyze national and regional economic conditions. The Department of Housing and Urban Development uses the data to evaluate housing programs. Financial institutions use these statistics to estimate mortgage demand. Private businesses use them for market planning, material use, and investment analysis.

SPECIAL FEATURES

Provides a designated principal economic indicator and the only source of current and consistent small area data on new authorizations for residential construction. Data are from public records and not subject to confidentiality restrictions.

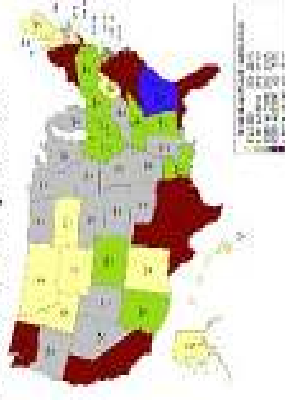

An establishment is generally a single, physical location at which economic activity occurs, such as a store or factory. An enterprise or firm, on the other hand, may consist of more than one location performing the same or different types of economic activities.

Construction work done may include new work, additions, alterations, or maintenance and repairs. Activities of these establishments generally are managed at a fixed place of business, but they usually perform construction activities at multiple project sites. Production responsibilities for establishments in this sector are usually specified in (1) contracts with the owners of construction projects (prime contracts) or (2) contracts with other construction establishments (subcontracts).

The Wholesale Trade sector comprises establishments engaged in wholesaling merchandise, generally without transformation, and rendering services incidental to the sale of merchandise. The merchandise described in this sector includes the outputs of agriculture, mining, manufacturing, and certain information industries, such as publishing.

Education



About

Educational attainment refers to the highest level of education that an individual has completed. This is distinct from the level of schooling that an individual is attending. See the School Enrollment Web site for information on current attendance.

Data on educational attainment are derived from a single question that asks, "What is the highest grade of school...has completed, or the highest degree...has received?" This question was first implemented in the 1990 Decennial Census and changed in the Current Population Survey in 1992. Prior to this, respondents were asked a two-part question that asked respondents to report the highest grade they had attended, and whether or not they had completed that grade. School enrollment captures the population who report being enrolled in a regular school. A regular school advances a person towards an elementary school certificate, high school diploma, or college, university, or a professional school (such as law or medicine) degree.

School districts are public school systems that provide regular, special, and/or vocational education services for children in pre-kindergarten through 12th grade. Public school systems in the United States are locally administrated, and their geographic structure varies by state and region.

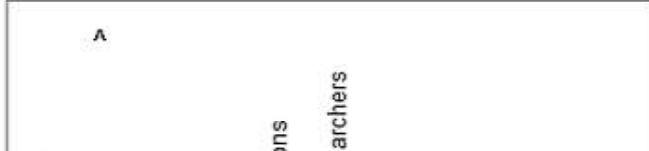

The American Housing Survey (AHS) is a statistical survey funded by the United States Department of Housing and Urban Development (HUD) and conducted by the U.S. Census Bureau. It is the largest regular national housing sample survey in the United States and contains information on the number and characteristics of U.S. housing units as well as the households that occupy those units.

Beginning in 2007 both the national (AHS-N) and metropolitan (AHS-MS) surveys are conducted every odd-numbered year rather than the previous practice of sampling every odd-numbered year for AHS-N and even-numbered year for AHS-MS. The 2007 sample consisted of 55,000 national housing units and 7 metropolitan sampling areas (MSAs) with 3,000 units for a total sample size of 76,000 housing units. In 2001, there were 119,117,000 housing units in the United States, with 106,261,000 and 12,855,000 vacant.

The metropolitan areas are revisited for an updated sample every six years. Since 1985, the survey data in both the national and metropolitan area samples are collected from the same homes each survey year, hence the AHS can track changes in these housing units over time. With each new national or metropolitan survey, new housing units are added to the sample to account for new construction since the last survey.

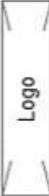

Census money income is defined as income received on a regular basis (exclusive of certain money receipts such as capital gains) before payments for personal income taxes, social security, union dues, medicare deductions, etc. Therefore, money income does not reflect the fact that some families receive part of their income in the form of noncash benefits, such as food stamps, health benefits, subsidized housing, and goods produced and consumed on the farm. In addition, money income does not reflect the fact that noncash benefits are also received by some nonfarm residents which may take the form of the use of business transportation and facilities, full or partial payments by business for retirement programs, medical and educational expenses, etc. Data users should consider these elements when comparing income levels. Moreover, users should be aware that for many different reasons there is a tendency in household surveys for respondents to underreport their income. Based on an analysis of independently derived income estimates, the Census Bureau determined that respondents report income earned from wages or salaries much better than other sources of income and that the reported wage and salary income is nearly equal to independent estimates of aggregate income.

Census also derives alternative income measures that systematically remove or add various income components such as deducting payroll taxes and federal and state income taxes and including the value of specific noncash benefits, food stamps, school lunches, housing subsidies, health insurance programs, and return on home equity. These alternative measures are derived from information collected in Census surveys along with information from other agencies such as the Centers for Medicare and Medicaid Services (CMS), the U.S. Bureau of Labor Statistics, the U.S. Department of Agriculture, the U.S. Internal Revenue Service, and the U.S. Office of Personnel Management (OPM).

Projections are estimates of the population for future dates. They illustrate plausible courses of future population change based on assumptions about future births, deaths, net international migration, and domestic migration. Projected numbers are typically based on an estimated population consistent with the most recent decennial census as enumerated, projected forward using a variant of the cohort-component method. In some cases, several alternative series of projections are produced based on alternative assumptions for future fertility, life expectancy, net international migration, and (for state-level projections) state-to-state or domestic migration. For each of these components of population change—fertility, mortality and net migration—three different assumptions about the future are applied. The series using the middle assumption for each component—generally designated as the “middle series”—is the most commonly used. Population projections are produced by age, sex, race and Hispanic origin, and are released periodically.

While projections and estimates may appear similar, there are some distinct differences between the two measures. Estimates are for the past, while projections are based on assumptions about future demographic trends. Estimates generally use existing data collected from various sources, while projections must assume what demographic trends will be in the future. In our current product offerings the user may see both an estimate and a projection available for the same date (e.g., July 1997), which may not agree because they were produced at different times. In such cases, estimates are the preferred data, unless the users' objective is to compare the number with others in the projected series.

Overview

The 2010 Census reported 308.7 million people in the United States, a 9.7 percent increase from the Census 2000 population of 281.4 million. This report discusses population change between 2000 and 2010 for several geographic levels, including regions, states, metropolitan and micropolitan statistical areas, counties, and places.

The increase of 9.7 percent over the last decade was lower than the 13.2 percent increase for the 1990s and comparable to the growth during the 1980s of 9.8 percent. Since 1900, only the 1930s experienced a lower growth rate (7.3 percent) than this past decade [See more](#)

History

The United States acquired the area of Louisiana from France in 1803 as part of the Louisiana Purchase, although the area east of the Mississippi River and north of Lake Pontchartrain and the southwestern boundary were disputed with Spain until 1812. Orleans Territory, which included the greater part of Louisiana, was organized on March 26, 1804. (The Louisiana Territory, organized on March 3, 1805, did not include any of the present-day state of Louisiana; the Louisiana Territory was the portion of the Louisiana Purchase that was north of the 33rd parallel, which is the current northern boundary of the state of Louisiana.) Louisiana was admitted to the Union on April 30, 1812, as the 18th state, with generally the same boundary as the present state.

Census data for Louisiana are available beginning with the 1810 census. The 1810 population is for Orleans Territory, which conformed to the present-day state boundary.

Data for the legally established state of Louisiana are available beginning with the 1820 census.

American Indian Areas

Louisiana has four federally-recognized American Indian reservations, two with off-reservation trust land. There are also five state designated tribal statistical areas (SDTSAAs).

Metropolitan and Micropolitan Statistical Areas and Related Statistical Areas

Louisiana has 8 metropolitan statistical, 17 micropolitan statistical areas, and 7 combined statistical areas.

Counties

There are 64 county equivalents in Louisiana known as parishes. Four parishes are not considered to be functioning governmental units because they have consolidated their functions with an incorporated place. East Baton Rouge Parish and Baton Rouge city are partially consolidated governmentally at the parish level. Baton Rouge city retains separate boundaries and some municipal functions. Lafayette Parish and Lafayette city are partially consolidated governmentally at the parish level. Lafayette city maintains separate boundaries and some municipal functions. Orleans Parish and New Orleans city are governmentally consolidated at the city level. Terrebonne Parish and Houma city is a nonfunctioning geographic entity with separate boundaries within the consolidated government. The governing body of each parish is the police jury, except for Jefferson and Plaquemines Parishes which each have parish councils.

County Subdivisions

There are 579 county subdivisions in Louisiana known as minor civil divisions (MCDs). There are 578 parish governing authority distnds, which are nongovernmentals, nonfunctioning subdivisions of the parish used for conducting elections. New Orleans city is independent of any MCD and serves as an MCD equivalent.

Places

There are 473 places in Louisiana; 304 incorporated places and 169 census designated places (CDPs). The incorporated places consist of 69 cities, 128 towns, and 107 villages. Houma city, though a legal entity, does not have a functioning government. The minimum population threshold for incorporation in Louisiana is 300. Villages have a population of up to 999, towns have a population of between 1,000 and 4,999, and cities have a minimum population of 5,000.
