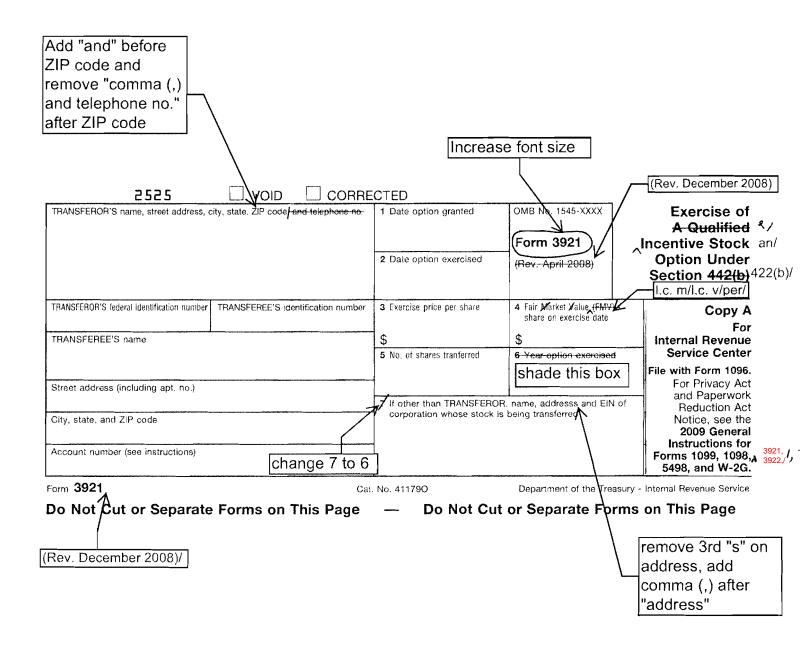
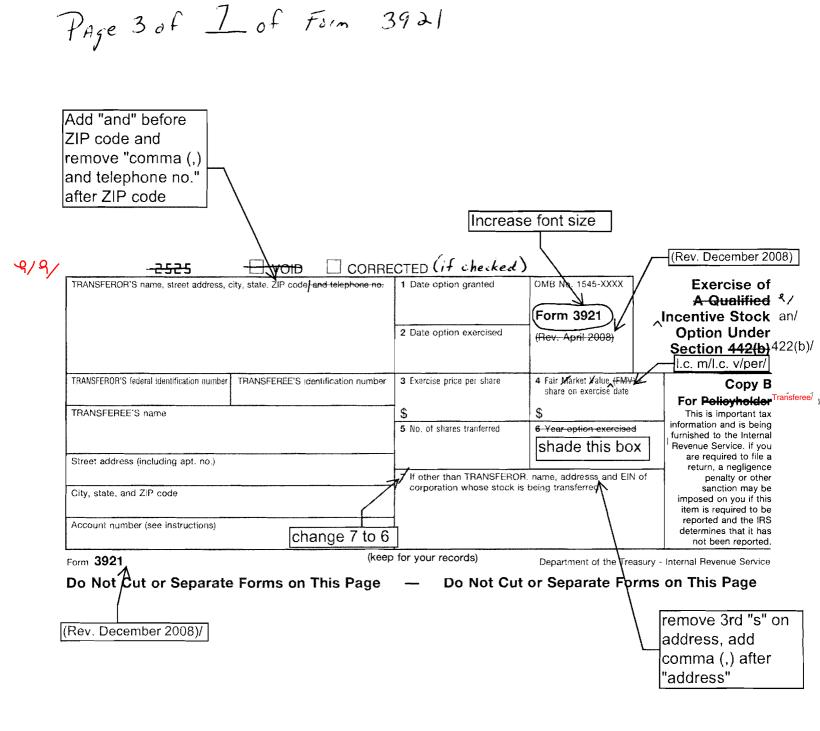

Instructions for Transferee

A payer, such as your employer or a stock transfer company who transfers your employers stock to you pursuant to the exercise of an incentive stock option, must give this form to you. You should retain this form to help you report the proceeds of sales of this stock until you have made a complete disposition of the stock. For assistance in reporting dispositions of this stock, see Pub. 525, Taxable and Nontaxable Income.

Account number. May show an account or other unique number the payer assigned to distinguish your account.

Box 1. Shows the date the option to purchase the stock was granted to you.

Box 2. Shows the date you exercised the option to purchase the stock.

Box 3. Shows the exercise price per share of stock.

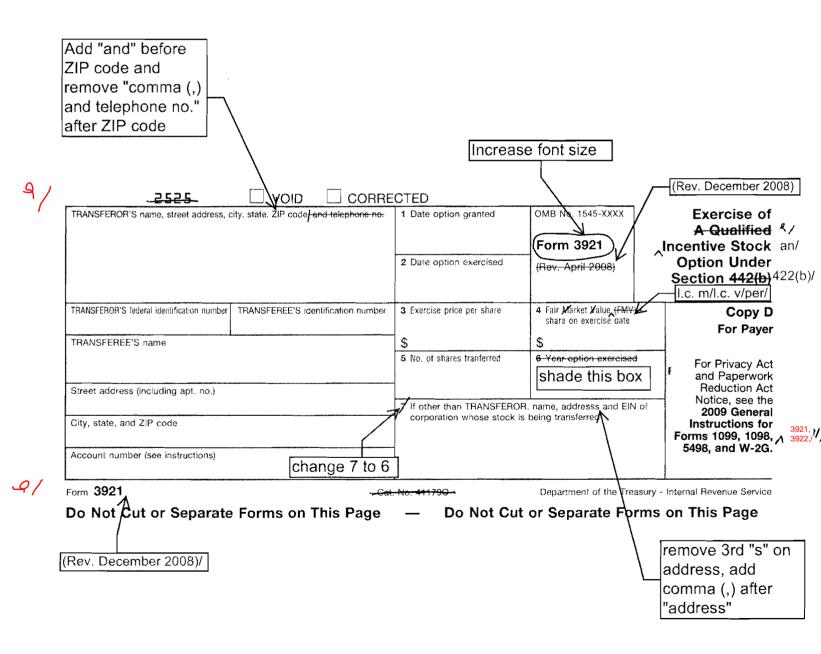
Box 4. Shows the fair market value (FMV) of a share of stock on the date the option to purchase was exercised.

Box 5. Shows the number of shares transferred pursuant to the exercise of the option.

Box 6. If other than the corporation shown in TRANSFEROR boxes in upper left corner on the front of this page, shows the name, address, and employer identification number (EIN) of the corporation whose stock is being transferred.

File Copy A of this form with the IRS by March 1, 2010. If you file electronically, the due date is March 31, 2010. To file electronically, you must have software that generates a file according to the specifications in Pub. 1220, Specifications for Filing Forms 1098, 1099, 5498, and W-2G 3921, 3922, Electronically. IRS does not provide a fill-in form option.
