Instructions for Transferee

Box 5. Shows the number of shares transferred pursuant to the exercise of the option.

Box 6. If other than the corporation shown in TRANSFEROR boxes in upper left corner on the front of this page, shows the name, address, and employer identification number (EIN) of the corporation whose stock is being transferred.

File Copy A of this form with the IRS by March 1, 2010. If you file electronically, the due date is March 31, 2010. To file electronically, you must have software that generates a file according to the specifications in Pub. 1220, Specifications for Filing Forms 1098, 1099, 5498, and W-2G Electronically. IRS does not provide a fill-in form option.
