Public Law 111-8, Afghan Allies Protection Act of 2009, provides special immigrant status for certain Afghans.

- The changes highlighted in green reflect the eligibility requirements already contained in Title VI of Public Law 111-8.
- The evidence requirements highlighted in red are not new requirements they have already been approved by OMB for filing the Form I-360 for Iraqi translators, USCIS is just listing the same requirements under the heading for Afghan Nationals to make it easier for the applicant to identify the requirements. However, USCIS is increasing the annual number respondents by 1,500 annually which is the numerical limitation provided in section 602(b)(3) of Public Law 111-8.
- The changes highlighted in yellow are non-substantive edits.

Paragraph 3, Afghan and Iraqi Translators/Interpreters: Remove the word "concurrently" from the last sentence, so it reads: "You cannot file it with Form I-485."</p> <p>In addition, if we are asking an applicant to check box "m", we should be telling them what to write in the line next to the box. Please edit the instruction to include guidance on what an applicant checking this box should write on the line for this classification. (This helps in the processing.)</p> <p>4.
