**(Rev. Proc. 2007-21)**

**12. ESTIMATED BURDEN OF INFORMATION COLLECTION**

Rev. Proc. 2007-21: To comply with Revenue Procedure 2007-21, a person must request rescission in writing within a certain period of time. The written request for rescission must include all of the information specified. It is estimated that the above requirements will affect 859 taxpayers per year, with a burden of approximately 0.25 to 0.75 hour per respondent, with an average of 0.5 hour, for an annual burden of 429.50 hours.

Estimates of the annualized cost to respondents for the hour burdens shown are not available at this time.

**13. ESTIMATED TOTAL ANNUAL COST BURDEN TO RESPONDENTS**

As suggested by OMB, our **Federal Register Notice** dated **March 10, 2010 (75 FR 11631)**, requested public comments on estimates of cost burden that are not captured in the estimates of burden hours, i.e., estimates of capital or start-up costs and costs of operation, maintenance, and purchase of services to provide information. However, we did not receive any response from taxpayers on this subject. As a result, estimates of the cost burdens are not available at this time.
