## 2010 SUPPORTING STATEMENT Christmas Tree Promotion, Research and Information Program 7 CFR Part 1214 OMB Number 0581-NEW (Proposed Order)

#### **CLEARANCE NOTATION:**

OMB review and approval of a new information collection is necessary for the establishment of a newly proposed Christmas Tree Promotion, Research and Information Program (Order (7 CFR Part 1214)). A separate information collection package is also being submitted for the referendum ballot. Upon approval and passing of the referendum, both collection packages will be merged into 0581-0093.

#### <u>Justification</u>

# 1. EXPLAIN THE CIRCUMSTANCES THAT MAKE THE COLLECTION OF INFORMATION NECESSARY. IDENTIFY ANY LEGAL OR ADMINISTRATIVE REQUIREMENTS THAT NECESSITATE THE COLLECTION.

A new Christmas Tree Promotion, Research and Information Order (Order) is being proposed under the Commodity Promotion, Research, and Information Act of 1996, (PL 104-127, 110 Stat. 1032, April 4, 1996, 7 U.S. C. 7411-7425). This legislation is hereinafter referred to as the 1996 Act. Under the enabling legislation, Congress has delegated the Department of Agriculture (USDA) the responsibility of establishing and overseeing agricultural commodity research and promotion orders, which may include a combination of promotion, research, industry information, and consumer information activities funded by mandatory assessments. These programs are designed to maintain, develop, and expand markets and uses for agricultural commodities. The Order was submitted by the Christmas Tree Checkoff Task Force (Task Force).

The Order would provide for the development and financing of a coordinated program of research, promotion, and information for Christmas trees. The program would include projects relating to research, information, advertising, sales promotion, market development and production research to assist, improve, or promote the marketing, distribution, competitive position and stimulate sales of Christmas trees.

The program would be administered by a Board appointed by the Secretary of Agriculture and financed by a mandatory assessment on producers and importers of Christmas trees. The Agricultural Marketing Service would provide oversight to ensure: (1) funds are collected and properly accounted for; (2) expenditures of all funds are for the purposes authorized by the enabling legislation; and (3) the Board's administration of the program conforms to USDA policy.

Section 515(i) of the 1996 Act provides authority to request from persons

covered under the Order any information required to carry out the responsibilities of the program. Each appointed Board is responsible for collecting assessments from the affected persons covered under the program in order to carry out the Board's responsibility. These programs require the use of the forms described in item 2 below.

## 2. INDICATE HOW, BY WHOM, AND FOR WHAT PURPOSE THE INFORMATION IS TO BE USED. EXCEPT FOR A NEW COLLECTION, INDICATE THE ACTUAL USE THE AGENCY HAS MADE OF THE INFORMATION RECEIVED FROM THE CURRENT COLLECTION.

The proposed Christmas Tree Promotion, Research and Information Order (Order) is being proposed under the 1996 Act and, if adopted, would be established by USDA through the issuance of an Order, and rules and regulations. A referendum would be conducted by USDA to determine if producers and importers of Christmas trees favor the implementation of the Order.

Under the Order, producers and importers of Christmas trees would be subject to a mandatory assessment of \$0.15 per tree to fund a coordinated program to maintain, develop, and expand the demand of Christmas trees. The Order would be administered by a 12 member Christmas Tree Promotion Board (Board) comprised of 11 producer members from 3 regions (5 members from the Western Region, 2 members from the Central Region, and 4 members from the Eastern Region), and 1 importer member.

The members would be appointed by the Secretary of Agriculture to administer the program with AMS oversight, and would be selected from nominations conducted by the Board through a nomination and balloting process for both producers and importers.

Board members would serve terms of three years and could serve a maximum of two consecutive terms. For the initial Board, terms will be staggered for two, three, and four year terms. The Board would use assessments collected under the Order to carry out research, promotion, and information activities. In order to carry out these responsibilities, producers and importers are required to submit certain information, as provided in Sections 515, 516, and 517 of the 1996 Act, and Sections 1214.41,1214.52, 1214.53, 1214.54, and 1214.71 of the Order.

A second information collection package that contains the referendum ballot for 114 burden hours is being submitted in a separate package because its approval is needed if an upfront vote is needed on whether to implement the program. Upon approval of both information collection packages they will be merged into one information collection package.

It is estimated that there are 12,455 respondents comprised of 12,255 producers and 200 importers. These 12,455 respondents are required to keep books and records to carry out the provisions of the Order. The 12,455 respondents differ from the number of respondents completing the forms identified on the AMS Form 71, due to the fact that not all of the producers and importers have to fill out the forms listed, but all producers and importers have to keep the books and records to show they have either paid the assessment or are

exempt from paying the assessment.

The information required under this program is gathered through the following forms, and is used by USDA's AMS, and the Board as described below:

a) <u>Background Information Form AD-755 (OMB 0505-0001) (Section</u> <u>1214.71</u>): This form contains questions to ascertain the nominee's qualifications for consideration of appointment to the Board by the Secretary of Agriculture. The form questions include: personal identification information, including name, social security number, date of birth, and address; length of time engaged in the production of Christmas trees; quantity of Christmas tress cut and sold; length of time engaged in importation of Christmas trees and the number of Christmas trees imported; employment information; professional affiliation(s); education; income sources for amounts over \$10,000; and criminal history. The form would be completed by all Board nominees including producers and importers. This information would be provided to the Board and forwarded to USDA for use in the nomination process. Upon approval of this collection, a change of worksheet will be submitted to increase the burden of 0505-0001 by 12 hours.

b) <u>Application for Exemption from Assessments (XMAS-AE) (Section</u> <u>1214.53)</u>: Producers who cut and sell or importers who import less than a predetermined quantity per year could claim an exemption from assessments. This form requires sales and importation data, supporting documentation, and certification. The form requests the minimum information necessary for proof that producers and importers should be exempt from assessments under the Order.

c) <u>Sales/Importer Report (XMAS-SI) (Section 1214.52</u>): Producers or importers would be required to report to the Board on a reporting period determined by the Board information necessary for the Board to perform its duties. For producers, the information may include: the total number of Christmas trees cut and sold during the reporting period; and the producer's tax identification number. For importers, the information may include: the total number of Christmas trees imported during such reporting period, Christmas trees imported during the reporting period, and period, and port of entry; and importer of record tax identification number.

**Importer Report (No form)** is a report submitted to the Board by the U.S. Customs Service (Customs), from information obtained at the port of entry. The report requires information regarding the total quantity of product imported during the reporting period and a record of each importation of such product during such period, giving quantity, date, and port of entry. Assessments are reported on the Importer Report on a calendar month basis and accompany the payment to the applicable Board. Under the Order, U.S. Customs would collect assessments on imported Christmas trees and remit the funds to the Board.

**Recordkeeping Requirements (Section 1214.71)** are required to maintain and make available information for inspection by the Board and USDA. Each

producer and importer subject to the 1996 Act and Order shall maintain appropriate records to carryout the requirements of theses regulations. Recordkeeping requirements will help provide for the effective operation of the Order, and its conformance with the 1996 Act.

d) <u>Organic Exemption Request Form AMS-15 (OMB No. 0581-0093)</u> (Section 1214.53). Under the Order, the form would be completed by producers and importers requesting exemption from paying assessments. Producers and importers requesting exemption must produce or import products that meet the requirements for a "100 percent organic" label under the National Organic Program (7 CFR Part 205), and are not part of a split operation. The form also includes a certification statement.

e) Nomination Appointment Form (XMAS-NF) (Section 1214.41).

This form would be used to nominate producers and importers to serve on the Board. For regional producers and importer representatives, the nomination form may be used to nominate persons to Board positions. Once all of the nominations for each position of the Board have been received, the Board will put the names on the ballot and send to eligible producers and importers to vote. Once the votes are tallied from the ballots those receiving the most votes would be nominated to the Board and forwarded to USDA for consideration by the Secretary of Agriculture.

**f)** <u>Nomination Appointment Ballot (XMAS-BL) (Section 1214.41).</u> This form would be used by producers and importers to vote on nominees to the Board. Once the votes are tallied from the ballots, those receiving the most votes would be nominated to the Board, and those nominees will be forwarded to USDA for consideration by the Secretary of Agriculture.

**Background Statement (No Form)** is information provided by producers and importers outlining their qualifications and desire to serve on the Board.

g) <u>Application for Reimbursement of Assessments (XMAS-RF)</u> (Section 1214.53). Under the Order, the form would be completed by importers requesting reimbursement for the assessments collected by the U.S. Customs Service on Christmas trees that should have been exempt from assessments. Importers requesting reimbursement must show the port of entry, entry date, number of trees and the amount of assessments collected to be reimbursed. In addition, the applicant must give name address, telephone number, tax identification number for proof payment of assessments for which they are requesting reimbursement.

h) <u>Application for a Refund (XMAS-RD) (Section 1214.54</u>). Under the Order, the form would be completed by producers and importers requesting a refund of assessments during the period beginning on the effective date of the Order and ending on the date the Secretary announces the results of the required referendum. If the required referendum fails, the Board shall promptly pay

refunds of assessments to those producers and importers requesting refunds. If the required referendum passes, no refunds will be paid. The form includes the applicant's name, address, telephone number, tax identification number for proof of assessments for which they are requesting a refund, and a certification statement.

3. DESCRIBE WHETHER, AND TO WHAT EXTENT, THE COLLECTION OF INFORMATION INVOLVES THE USE OF AUTOMATED, ELECTRONIC, MECHANICAL, OR OTHER TECHNOLOGICAL COLLECTION TECHNIQUES OR OTHER FORMS OF INFORMATION TECHNOLOGY, E.G., PERMITTING ELECTRONIC SUBMISSION OF RESPONSES, AND THE BASIS FOR THE DECISION FOR ADOPTING THIS MEANS OF COLLECTION. ALSO DESCRIBE ANY CONSIDERATION OF USING INFORMATION TECHNOLOGY TO REDUCE BURDEN.

Upon approval, these forms will be used to submit information directly to the Board, which administers the Order. The Board is not part of a Federal agency, but is a commodity industry Board that operates under Federal authority and USDA-AMS oversight. Though AMS is committed to complying with the e-Government Act, which requires Government agencies in general to provide the public the option of submitting information or transacting business electronically to the maximum extent possible, the availability and submission of forms electronically is at the Board's discretion. Currently, forms are transmitted by fax machine and postal delivery.

## 4. DESCRIBE EFFORTS TO IDENTIFY DUPLICATION. SHOW SPECIFICALLY WHY ANY SIMILAR INFORMATION ALREADY AVAILABLE CANNOT BE USED OR MODIFIED FOR USE FOR THE PURPOSE(S) DESCRIBED IN ITEM 2 ABOVE.

The information to be included on these forms is not available from other sources because such information relates specifically to individual producers and importers who are subject to the proposed Order. The primary sources of information would be books and records pertaining to the production of Christmas trees and imports of Christmas trees.

Information generated by State, Federal, and private sources would not generate information of a proprietary nature relative to producers and importers who are subject to the provision of the Order. Such information would not be detailed enough to be used for the specific purposes of determining the amount of Christmas trees cut and sold or imported. Therefore, there is no practical method for collecting the required information without the use of these forms.

## 5. IF THE COLLECTION OF INFORMATION IMPACTS SMALL BUSINESSES OR OTHER SMALL ENTITIES (ITEM 5 OF THE OMB FORM 83-1), DESCRIBE THE METHODS USED TO MINIMIZE

#### **BURDEN.**

The Small Business Administration defines, in 13 CFR part 121, small agricultural producers as those having annual receipts of no more than \$750,000 and small agricultural service firms (producers and importers) as those having annual receipts of no more than \$7.0 million. Under these definitions, the majority of the producers would be considered small entities, while most importers would not. We have estimated the number of respondents for this collection is 12,455, and we estimate that 9,192 are considered small businesses.

Information collection requirements have been reduced to the minimum requirements of the Order. The primary sources of information used to complete the required forms are readily available from normal business records maintained by producers and importers. Such information can be supplied without data processing equipment or outside technical expertise.

Thus, the information collection and reporting burden is relatively small, and requiring the same reporting requirements for all producers and importers does not significantly disadvantage any producer or importer that is smaller than the industry average.

## 6. DESCRIBE THE CONSEQUENCE TO FEDERAL PROGRAM OR POLICY ACTIVITIES IF THE COLLECTION IS NOT CONDUCTED OR IS CONDUCTED LESS FREQUENTLY, AS WELL AS ANY TECHNICAL OR LEGAL OBSTACLES TO REDUCING BURDEN.

The information will be collected through a mandatory research and promotion program designed to maintain, develop, and expand markets for Christmas trees. If the information collection herein were not collected, the Board could not carry out the coordinated research, promotion, consumer education, and industry information program on Christmas trees, ensure compliance with the mandatory program or ensure proper assessment collection. Collecting data less frequently also would limit the Secretary's ability to oversee the Order.

## 7. EXPLAIN ANY SPECIAL CIRCUMSTANCES THAT WOULD CAUSE AN INFORMATION COLLECTION TO BE CONDUCTED IN A MANNER:

- REQUIRING RESPONDENTS TO REPORT INFORMATION TO THE AGENCY MORE OFTEN THAN QUARTERLY;

- REQUIRING RESPONDENTS TO PREPARE A WRITTEN RESPONSE TO A COLLECTION OF INFORMATION IN FEWER THAN 30 DAYS AFTER RECEIPT OF IT;

- REQUIRING RESPONDENTS TO SUBMIT MORE THAN ANORIGINAL AND TWO COPIES OF ANY DOCUMENT;

- REQUIRING RESPONDENTS TO RETAIN RECORDS, OTHER THAN HEALTH, MEDICAL, GOVERNMENT CONTRACT, GRANT-IN-AID, OR TAX RECORDS FOR MORE THAN 3 YEARS;

- IN CONNECTION WITH A STATISTICAL SURVEY, THAT IS NOT DESIGNED TO PRODUCE VALID AND RELIABLE RESULTS THAT CAN BE GENERALIZED TO THE UNIVERSE OF STUDY;

- REQUIRING THE USE OF A STATISTICAL DATA CLASSIFICATION THAT HAS NOT BEEN REVIEWED AND APPROVED BY OMB;

- THAT INCLUDES A PLEDGE OF CONFIDENTIALITY THAT IS NOT SUPPORTED BY AUTHORITY ESTABLISHED IN STATUE OR REGULATION, THAT IS NOT SUPPORTED BY DISCLOSURE AND DATA SECURITY POLICIES THAT ARE CONSISTENT WITH THE PLEDGE, OR WHICH UNNECESSARILY IMPEDES SHARING OF DATA WITH OTHER AGENCIES FOR COMPATIBLE CONFIDENTIAL USE; OR

- REQUIRING RESPONDENTS TO SUBMIT PROPRIETARY TRADE SECRET, OR OTHER CONFIDENTIAL INFORMATION UNLESS THE AGENCY CAN DEMONSTRATE THAT IT HAS INSTITUTED PROCEDURES TO PROTECT THE INFORMATION'S CONFIDENTIALITY TO THE EXTENT PERMITTED BY LAW.

There are no special circumstances. The collection of information is conducted in a manner consistent with the guidelines in 5 CFR 1320.6.

8. A 60-day notice for comments is embedded in a proposed rule published in the Federal Register on XX, 2010 (XX FR XXXX). No comments are expected.

Mr. Christopher Salisbury, Legal Counsel to the Christmas Tree Checkoff Task Force, telephone number (202) 842-2345; and Ms. Betty Malone, Chairperson of the Christmas Tree Checkoff Task Force, telephone number (541) 929-2289 were contacted on their views of the information collection.

The Order has not yet been implemented. There are no obstacles to consulting with industry members who must submit information to the Board. Industry members are consulted on an ongoing basis on the information collection requirements.

### 9. EXPLAIN ANY DECISION TO PROVIDE ANY PAYMENT OR GIFT TO RESPONDENTS, OTHER THAN REMUNERATION OF CONTRACTORS OR GRANTEES.

AMS does not provide payments or gifts to respondents.

## 10. DESCRIBE ANY ASSURANCE OF CONFIDENTIALITY PROVIDED TO RESPONDENTS AND THE BASIS FOR THE ASSURANCE IN STATUTE, REGULATION, OR AGENCY POLICY.

Section 1205(m)(2) of the 1996 Act provides that information collected from books and records will be kept confidential by those individuals having access to such information. The 1996 Act also provides for a fine and/or imprisonment for employees of the Board or USDA convicted of violating this confidentiality provision.

All information collected will be treated as confidential, as indicated on the forms and in conformance with the Privacy Act and Freedom of Information Act. Other confidential information will be withheld from public review under the Freedom of Information Act and the Privacy Act, 5 USC 552.

Questions of a sensitive nature are not included on any form. The only private information required is on the Background Information Form that a nominee to the Board must fill out. These questions are asked to ascertain his/her qualifications to serve on the Board and include: personal identification information, including name, social security number, date of birth, and address; length of time engaged in the production of Christmas trees; quantity of Christmas trees cut and sold; length of time engaged in importation of Christmas trees and the number of Christmas trees imported; employment information; professional affiliation(s); education; income sources for amounts over \$10,000; and criminal history. The form would be completed by all Board nominees including producers and importers. This information would be provided to the Board and forwarded to USDA for use in the nomination process. This information is provided to the Secretary for use in the selection process.

# 12. PROVIDE ESTIMATES OF THE HOUR BURDEN OF THE COLLECTION OF INFORMATION.

PROVIDE ESTIMATES OF ANNUALIZED COST TO RESPONDENTS FOR THE HOUR BURDENS FOR COLLECTIONS OF INFORMATION, IDENTIFYING AND USING APPROPRIATE WAGE RATE CATEGORIES. The respondents' estimated annual cost of providing information to the Board is \$349,371. An estimated number of 12,455 respondents would provide information to the Board annually. This total has been estimated by multiplying 10,587 hours by \$33, the average mean hourly earnings of professional, specialty and technical white collar occupations, and executive, administrative, and managerial white collar occupations by worker and establishment characteristics and geographic areas (metropolitan). Data for computation of this hourly wage were obtained from the U.S. Department of Labor Statistics' publication, "National Compensation Survey: Occupational Wages in the United States, June 2005", published August 2006 (Bulletin 2581). - 13. PROVIDE AN ESTIMATE OF THE TOTAL ANNUAL COST BURDEN TO RESPONDENTS OR RECORDKEEPERS RESULTING FROM THE COLLECTION OF INFORMATION. (DO NOT INCLUDE THE COST OF ANY HOUR BURDEN SHOWN IN ITEMS 12 AND 14).

GENERALLY, ESTIMATES SHOULD NOT INCLUDE PURCHASES OF EQUIPMENT OR SERVICES, OR PORTIONS THEREOF, MADE: (1) PRIOR TO OCTOBER 1, 1995, (2) TO ACHIEVE REGULATORY COMPLIANCE WITH REQUIREMENTS NOT ASSOCIATED WITH THE INFORMATION COLLECTION, (3) FOR REASONS OTHER THAN TO PROVIDE INFORMATION OR KEEPING RECORDS FOR THE GOVERNMENT, OR (4) AS PART OF CUSTOMARY AND USUAL BUSINESS OR PRIVATE PRACTICES. There are no capital, startup, operation, or maintenance costs associated with this program. The primary sources of information will be books and records pertaining to production or importation of Christmas trees that are normally maintained as part of usual and customary business practices.

# 14. PROVIDE ESTIMATES OF ANNUALIZED COST TO THE FEDERAL GOVERNMENT. The Agency requests approval not to display the expiration date for OMB approval of the information collection. This requirement significantly affects mandatory programs by having to destroy otherwise usable forms when the date expires. Such needless actions are counter-productive to the Administration's goal of increasing program efficiency, as well as the effect that an expiration date could have on the Agency. The impact of the expiration date requirement on administrative and regulatory forms for the programs can adversely affect the operation and enforcement of statutes. Inadvertent use of a form with an expired date poses an opportunity for those looking for a means of disruption to challenge paying for services rendered, the validity of the collection of information, or legal requirement imposed by regulations or statutes.

Additionally, the Board office orders forms well in advance of the fiscal year, so that forms can be mailed to producers and importers in a timely manner. The Boards of existing programs typically attempt to order forms in quantities large enough to get a price break. If the Board's office needs to order more forms prior to an OMB submission for extension of approval, there are no guarantees that a requested expiration date will be approved by OMB. There is also some confusion among respondents thinking their annual applications are good for the length of time noted in the expiration date, rather than expiring at the end of the marketing season.

Lastly, having an expiration date on forms in addition to the creation date and/or revision date could cause confusion to the users of the forms, which could result in delays in payments for services. A delay in payments from users of program services could lead to additional late payment costs and ultimately legal challenges by the users, thereby increasing costs and inefficiencies in the Agency.
