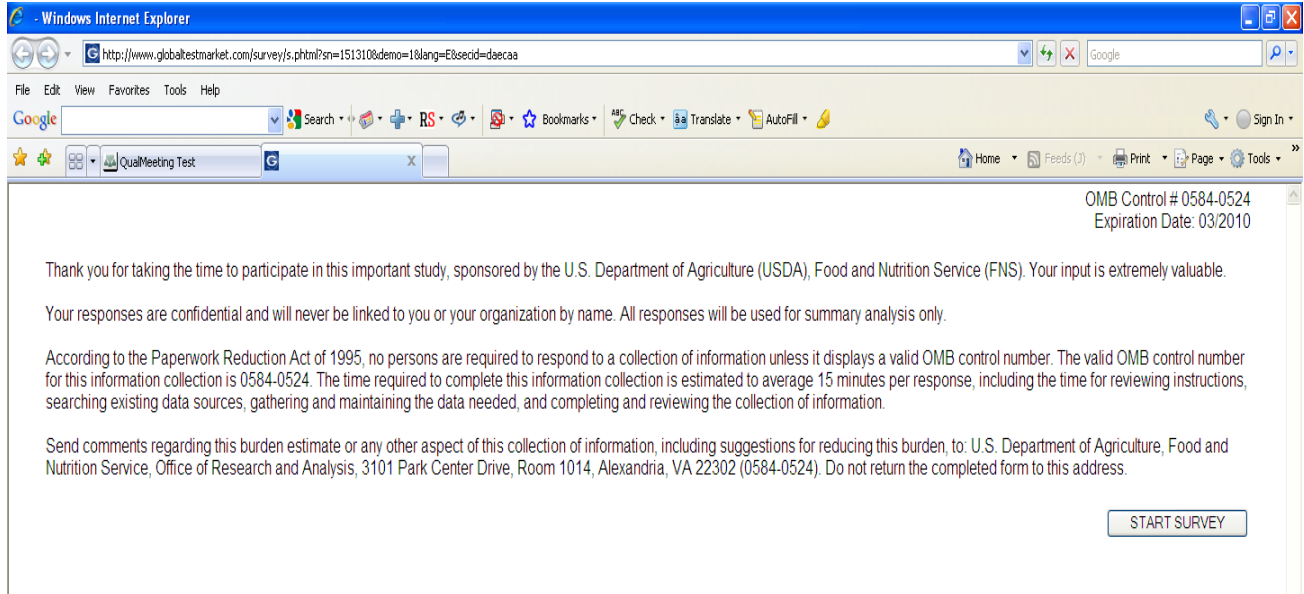

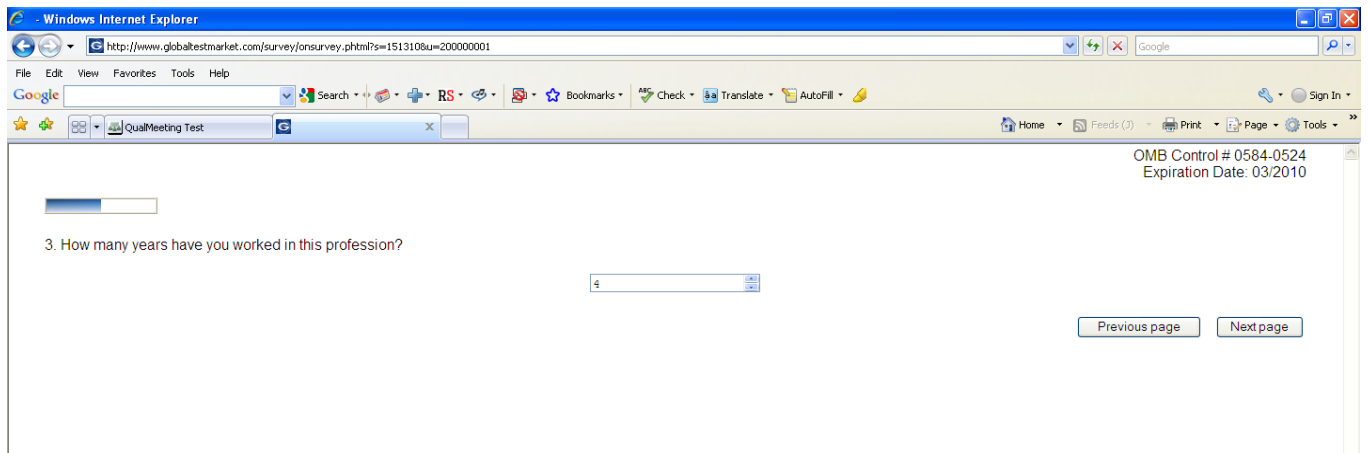
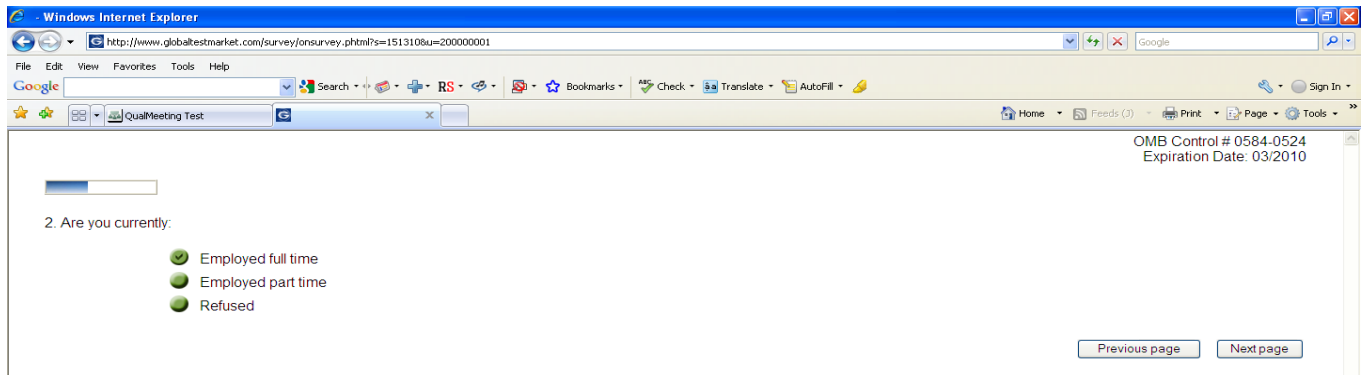
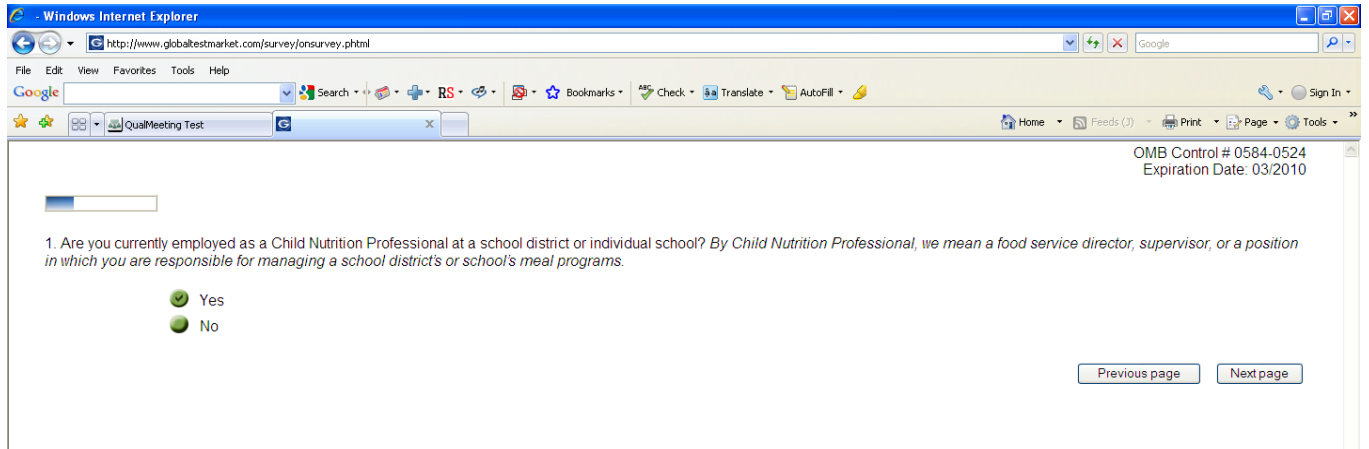
Screen Shot 1: Introduction and OMB Burden Statement
