Inspections will be conducted on vessels tied to docks at Dutch Harbor, Alaska; Kodiak, Alaska; and in the Puget Sound area of Washington State.

An electronic monitoring system inspection report, valid for 12 months from the date it is signed by NMFS, will be issued to the vessel owner if the electronic monitoring system meets the requirements. The vessel owner must maintain a current electronic monitoring system inspection report onboard the vessel at all times the vessel is required to provide an approved electronic monitoring system. The electronic monitoring system inspection report must be made available to the observer, NMFS personnel, or to an authorized officer upon request.
