If you are requesting Premium Processing Service on Form I-140 for a preference category that is Premium Processing eligible, you must include Form I-907, and send the entire Form I-907/I-140 package to the correct filing location listed below. Before you file, note the different filing addresses. Failure to follow these instructions may result in your application or petition being rejected, delayed, or denied.</p>	<p>Page 3, Premium Processing Service for Form I-140- Initial Filings</p> <p>If you are requesting Premium Processing Service on Form I-140 for a preference category that is Premium Processing eligible, file Form I-140 together with Form I-907 at either the USCIS Nebraska Service Center or the USCIS Texas Service Center, depending on the location of the beneficiary's permanent employment.</p> <p>Before you file, please note the different filing locations below.
