<b>Who must comply?</b>	Owners of marine portable tanks and owners/designers of non-specification portable tanks.
<b>What is this collection about?</b>	This information collection requires an owner who proposes alterations to a marine portable tank or a non-specification portable tank design used to transfer hazardous materials during offshore operations to provide plans and technical information to the Coast Guard (CG).
<b>Where do I find the requirements for this information?</b>	Title 46 CFR 64.9 and 98.33, are available at — <a href="http://ecfr.gpoaccess.gov">http://ecfr.gpoaccess.gov</a> , select TITLE 46 – SHIPPING, and follow it to the respective sections.
<b>When must information be submitted to the Coast Guard?</b>	Information must be submitted to the CG prior to construction or modification of a portable tank.
<b>How is the information submitted?</b>	In writing or electronically via e-mail. Information must be submitted to the CG Marine Safety Center (MSC). <b>What happens when complete information is received?</b>	Once all required information has been provided and the CG approves it, you will be notified in writing.
