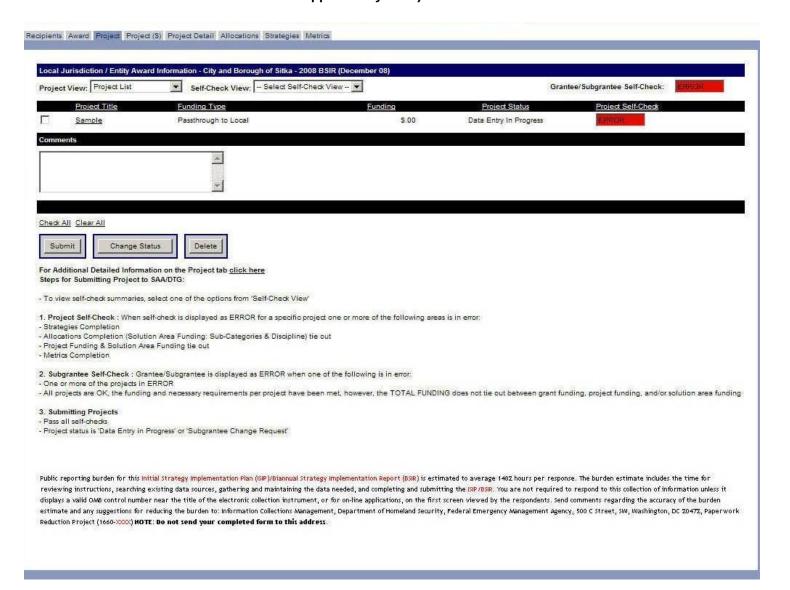
Funding Module – Project Tab – Create Project – Third Screen

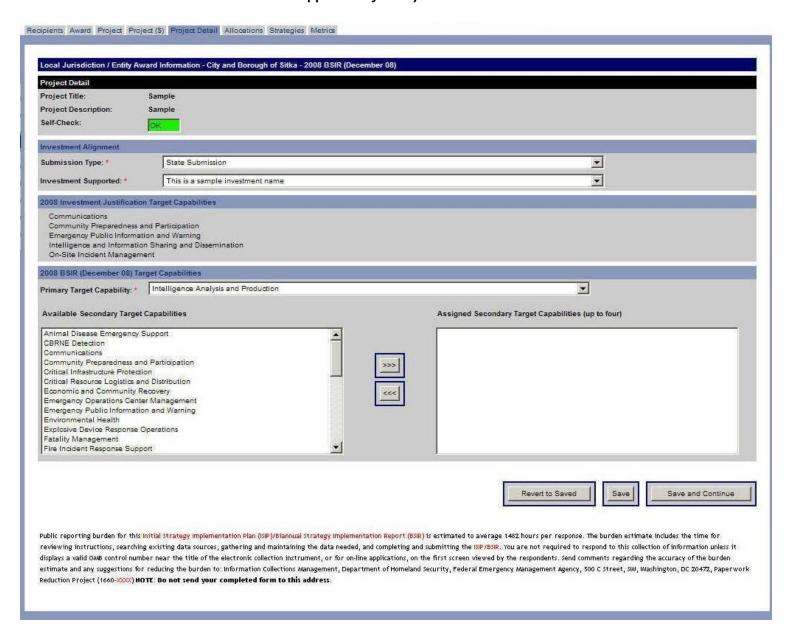

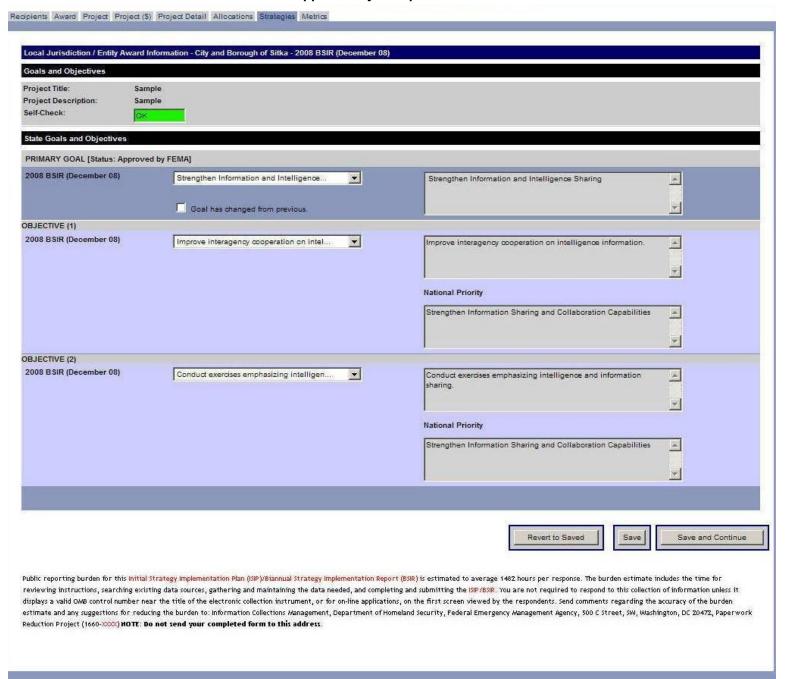
