CDC-INFO will continue to offer two customer satisfaction surveys, both of which were approved under the previous OMB package. The surveys require minimal changes from the previously approved versions. The changes to the surveys will allow CDC-INFO to collect race/ethnicity data that is consistent with the Census form that gives participants the opportunity to identify as multi-racial. If you are Native Hawaiian or Other Pacific Islander, press 6.

 Deletion of survey item which mentions the CDC-INFO Live Phone Follow-up Survey since the CDC-INFO Live Phone Follow-Up Survey has been discontinued, the survey item requesting participation will be deleted.

#### Deleted Question #9 (from currently approved version of instrument)
