**Instructions for Completing Form 3-186**

<b>If you are...</b>	<b>then you need to do the following:</b>
<b>selling, trading, or giving away migratory waterfowl directly to the recipient,</b>	1. You (the seller) must complete all sections of the form and sign the certification, even if you are giving the birds or eggs as a gift. 2. Make sure that the recipient of the birds or eggs (whether buying them or receiving them as a gift) signs the certification. 3. Give the recipient the original copy of the completed form. 4. Retain one copy as your record of the transaction. 5. Mail one copy to the Regional FWS Migratory Bird Permit Office responsible for your State before the end of the month in which you transfer the birds or eggs.
<b>conducting your transaction by mail,</b>	1. You (the seller) must complete all sections of the form and sign the certification, even if you are giving the birds or eggs as a gift. 2. Send the completed form to the recipient of the birds or eggs (whether buying them or receiving them as a gift) on the date the birds are shipped. <ul style="list-style-type: none"> <li>a. Have the recipient sign the certification.</li> <li>b. Have the recipient keep the original copy and return a copy to you.</li> </ul> 3. Retain one copy as your record of the transaction. 4. Mail one copy to the Regional FWS Migratory Bird Permit Office responsible for your State before the end of the month in which you transfer the birds or eggs.

Notice

Privacy Act (5 U.S.C.552a): The gathering of information on fish and wildlife is authorized by the Migratory Bird Treaty Act (16 U.S.C. 703 et seq.), and Parts 13 and 21 of Title 50 of the Code of Federal Regulations.
