10. ABSTRACT The National Drug Threat Survey is designed to collect information on the nature and extent of the threat posed by the trafficking and distribution of illicit drugs in the United States. The survey is administered to a stratified sample of state and local law enforcement agencies and respondent data are used to produce national, regional, and state estimates of the threats posed by illicit drugs. The estimates are used in various threat assessments and reports produced by NDIC.
