**NOTICE OF RIGHT TO PROTECT CERTAIN INFORMATION FROM DISCLOSURE**

The Export Administration Act permits you to protect from public disclosure information regarding the quantity, description, and value of commodities or technical data supplied in item 11 of this report and in any accompanying documents. *If you do not claim this protection, all of the information in your report and accompanying documents will be made available for public inspection and copying.*
