My questions will cover the partnership and its activities in math and science education. Overall, the interview should take no more than 7 hours of your time during the three-day site visit. All of your responses will be confidential.

A. PARTNERSHIPS

The first portion of the interview will cover the partnership's priorities, activities, outcomes, and content. Wherever possible, please note the timing or dates of the activities.

1. Shared Partnership Vision and Priorities

a. **Partners.** Please identify the lead partner, core partners, and other partners in this partnership. Within the partnering institution for higher education (IHE), which academic department(s) are the leaders? [Obtain a list or handout giving the formal names of these departments.]

b. **Creation and Maintenance.** To what extent has the partnership created and maintained a common vision and set of priorities? To what extent, and why, does each of the core partners understand and maintain the same broad vision and priorities? What conditions have hindered or helped these processes? [Probe for awareness that a major objective is to strengthen K-12 student performance, as well as for the partnership to be an R&D project.] [Obtain documentation, including logic models that reflect vision and priorities.]

2. Pre-existing Partnerships

a. **Identity.** What portions, if any, of the partnership had a pre-existing relationship that dealt with goals similar to those of the current partnership? Likewise, had key partnership leaders from different institutions previously collaborated?

b. ***New or Modified Institutional Arrangements.*** Besides joint activities, has the partnership been associated with new or modified institutional arrangements between or among the partners, and if so, how? ¹The objective is not to list all of a partnership's sponsored events (e.g., individual workshops) but to understand how these events might be clustered under a coherent activity or "project" or "program" (e.g., summer institutes). Typical activities would therefore include a professional development institute or degree program (preservice or inservice), a project to review and modify a district's curriculum standards, internship programs for K-12 teachers or students, a program to make subgrants to schools or districts for self-proposed activities, or a program to encourage university-based research on mathematics or science education.

C. TEACHER QUALITY, QUANTITY, AND DIVERSITY

Next, I would like to discuss the priorities, implementation, and outcomes for activities aimed at teacher quality, quantity, and diversity. Throughout this discussion, please clarify the grade levels and academic subjects involved, distinguishing especially among elementary, middle, and high schools and between mathematics and science.

1. Partnership's Priorities

DESCRIPTIVE PROFILE OF ENACTED PROFESSIONAL DEVELOPMENT (PD)

A. Participants

1. Role being targeted by PD (teacher, teacher leader, principal)
2. Part of a school-based team attending the PD (or not), with PD supporting a structured professional learning community
3. Part of a team operating at the district level, even if representing different schools
4. Whether volunteer or mandated by district to attend PD
5. Amount of stipend, if any (assumes that everyone's expenses are fully paid)
6. If PD was grade and subject specific, whether participant returned to same venue after the PD

B. Providers:

1. Individual profile of each provider, covering experience and expertise as a provider
2. Training and experience in the content of the PD (could be curricular or leadership content)
3. Whether has offered this particular PD before or not, and if so, how many times or seasons
4. Any kudos or feedback from prior participants about performance as a provider

C. PD Setting:

1. Length of PD (how many consecutive hours over how many consecutive days)
2. If off-site, length and mode of travel
3. Convenience: timing of PD in relation to participants' normal school and vacation schedules
4. Size of PD classes, length of classes, and no. of classes per day
5. If residential PD, quality of accommodations and whether other family members are present
6. Nature of institution sponsoring the PD (IHE, state or district, or independent nonprofit)

D. PD Curriculum:

1. Subject, topics, and levels covered by PD "courses"
2. Texts and materials used in each "course"
3. What previous research, if any, was found about the course
4. Whether course was previously offered, and feedback reported from the experiences
5. Whether course covers specific ways of teaching the same material in the participant's K-12 classroom
6. Whether course includes preparation of any kind of plan or action plan for later adapting what was learned for the participant's K-12 classroom

E. PD Instruction:

1. Whether a single, pair, or a team of providers for the same course (the same class?)
2. Amount of didactic versus participatory instruction
3. Extent and nature of cooperative or peer-peer learning
4. Use of hands-on exercises and materials
5. For inquiry-based contents, actual demonstration and practice in inquiry-based methods
6. Frequency and amount of PD homework, classroom assessments, and group projects
7. Whether participants receive feedback about or discuss their performance

F. PD Assessment:

1. Group scores on content knowledge tests
2. Group scores on any other tests of participants
3. Results of any observations of PD classes (e.g., to check for fidelity, time-on-task, etc.)
4. Assessment of PD providers' performance (even if only based on participants' ratings)

D. CHALLENGING COURSES AND CURRICULA

I would like to discuss some similar issues, except by changing the main topic to challenging courses and curricula. Throughout the discussion, please again clarify the grade levels and academic subjects involved, distinguishing especially among elementary, middle, and high schools and between math and science.

1. Partnership's Priorities

a. **Selection Rationale.** How did the partnership select its K-12 curriculum-oriented activities? [*Probe for: continuation of a pre-existing activity; use of a formal needs assessment (if so, obtain data); a derived consensus among original partners; or use of research and education theory.*]

b. **Relationship to Other Partnership Activities.** As implemented, how have the activities fit within the partnership's overall work? [*An illustrative relationship would be where the partnership has helped to develop district or classroom assessments or lesson planning and also has provided related teacher training.*]

c. **Assumed Relationship to K-12 Student Performance.** In principle, how are the curriculum activities related to K-12 student performance? [*Probe for whether the relationship is "proximal" (serving current K-12 students) or "distal" (serving some future group if not generation of K-12 students).*]

2. Implementation and Outcomes

a. **In-depth Description of Main Activity.** Describe the main curriculum-oriented activity. How is the desire to attain a "challenging" curriculum operationalized or otherwise expressed in this activity? [*Probe for operational definitions of "challenging" curricula; obtain a formal list of the curricula being used and a sample of the curriculum material.*]

b. **Math and Science Content.** How is this activity maintaining quality control over its math and science content?

c. **Instructional Practices.** How is this activity maintaining quality control over the quality of the instructional practices used in the activity?

d. **Implementation Progress.** To what extent has the activity progressed toward its originally-stipulated outcomes?

e. **Implementation Conditions.** What conditions have facilitated, impeded, or otherwise influenced progress in implementing the activity?

[*Probe for alignment with standards and assessments and changes in district curricula.*]

f. **Implementation Outcomes.** What have been the results of the activity in terms of K-12 teachers' classroom practices, or in terms of K-12 student performance?

E. ROLE OF IHE DISCIPLINARY FACULTY

Again, I would like to explore the same issues as just discussed, except now focusing on the role of IHE STEM discipline faculty (faculty who do their main research in a STEM discipline field and who are members of a STEM discipline department).

1. Partnership's Priorities

a. **Selection Rationale.** How did the partnership select its discipline faculty activities?

[Probe for: continuation of a pre-existing activity; use of a formal needs assessment (if so, obtain data); a derived consensus among original partners; or use of research and education theory.]

b. **Relationship to Other Partnership Activities.** As implemented, how have the discipline faculty's activities fit within the partnership's overall work? *[An illustrative relationship would be where the partnership supports discipline faculty research that also involves K-12 teachers or students as interns.]*

c. **Assumed Relationship to K-12 Student Performance.** In principle, how are the discipline faculty's activities related to K-12 student performance? *[Probe for whether the relationship is "proximal" (serving current K-12 students) or "distal" (serving some future group if not generation of K-12 students).]*

2. Implementation and Outcomes

a. **Discipline Faculty's Activities.** To date, what have been the amount and quality of the activities, and how have they met or not met the partnership's original expectations? *[Probe for the array of activities and obtain relevant materials.]*

b. **Disciplinary Faculty Products/Contributions.** Thus far, how have the discipline faculty contributed to new ideas or innovations in mathematics and science education? *[Probe for specific products/contributions.]*

c. **Professional Advancement.** How has involvement with K-12 work counted toward professional advancement in the discipline faculty's home department? Have there been any changes in formal IHE policies, and if so, why or why not? *[Probe for new research opportunities and career tracks, as well as differences, if any, between junior and senior faculty.]*

d. **Implementation Progress.** To what extent have the activities progressed toward their originally-stipulated outcomes?

e. **Implementation Conditions.** What conditions have facilitated, impeded, or otherwise influenced progress in implementing the activities? *[Probe for the spanning of boundaries across IHE departments or schools, identifying the widest spans and how they have been managed or coordinated.]*

f. **Implementation Outcomes.** What have been the results of the activities in terms of K-12 teachers' or students' performance?

F. EXPLANATIONS REGARDING THE PARTNERSHIP'S WORK

The earlier sections have already asked about the conditions that have possibly facilitated, impeded, or otherwise influenced progress in implementing the partnership and its activities (see Qs. A4c, C2e, D2e, and E2e). Without repeating those responses, I would like to get a fuller and broader view of the workings of the partnership.
