On the behalf of all supporters of wildlife, thank you for participating in the Harvest Information Program migratory bird harvest survey last hunting season. The important information you provided helped enable us to estimate the total harvest of migratory birds in the United States. Because you have already made a valuable contribution, we are asking for your help again this coming season. We are asking selected hunters to send us wings from each woodcock, band-tailed pigeon, and/or rail that they shoot next season. Volunteering to send us the wings from these birds that you bag will provide us with more crucial information.

Biologists will examine your specimens to determine the birds' species, age, and sex. This information is vital for helping us better manage our migratory bird resource. For example, the specimens that hunters contribute will allow us to estimate the number of young-of-the-year birds that were harvested, which tells us how successful the birds were during the nesting season.

If you will be able to send us wings from the birds that you bag, please provide the information requested below and return this letter in the postage-paid envelope. Please return it by **July 13** so that we can send your postage-paid wing envelopes in time for the hunting season.
