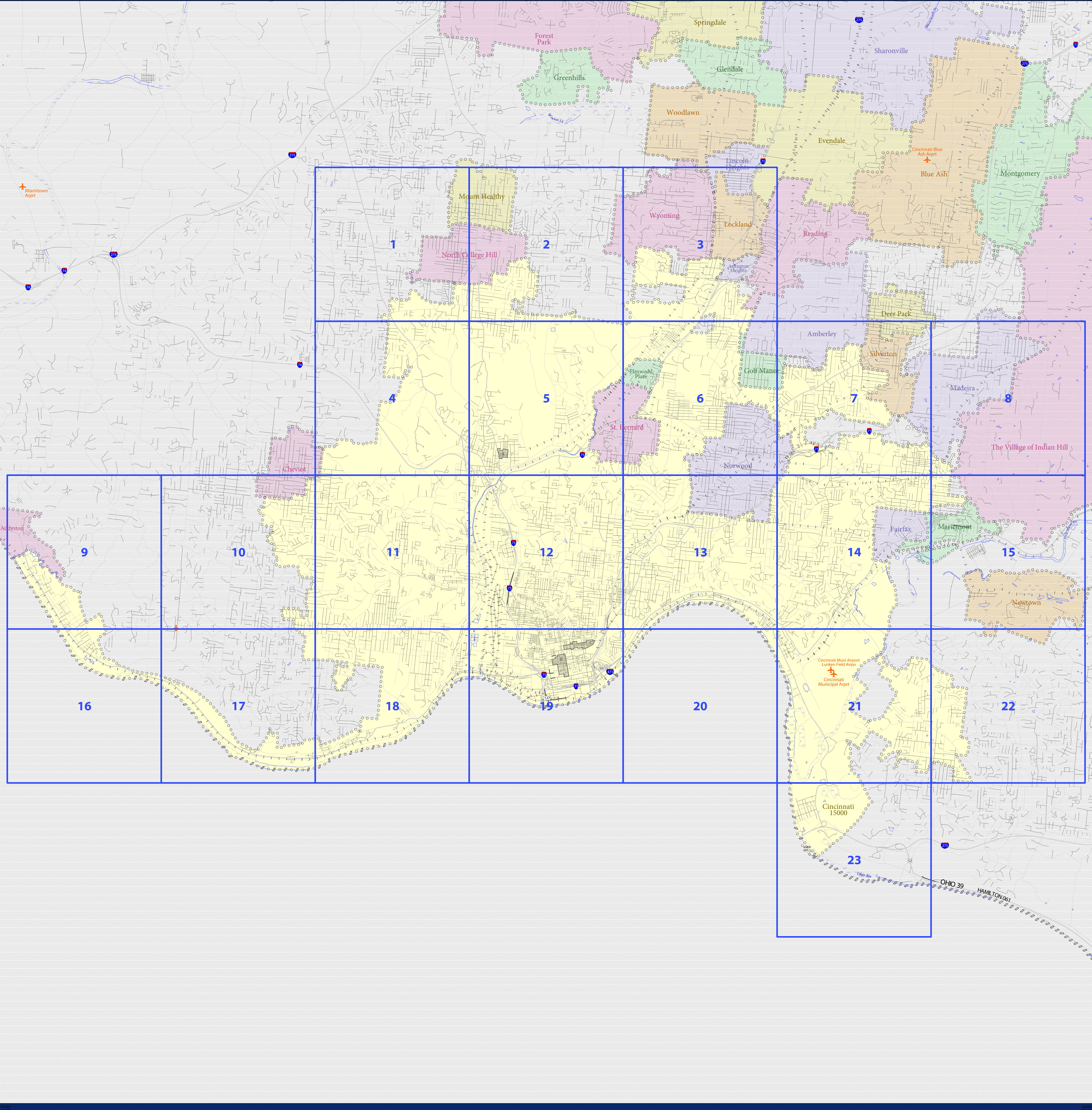

² Incorporated place name color correlates to the incorporated place fill color.

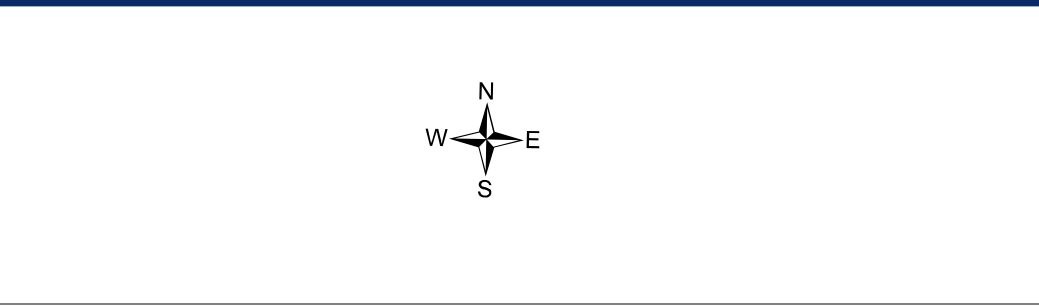
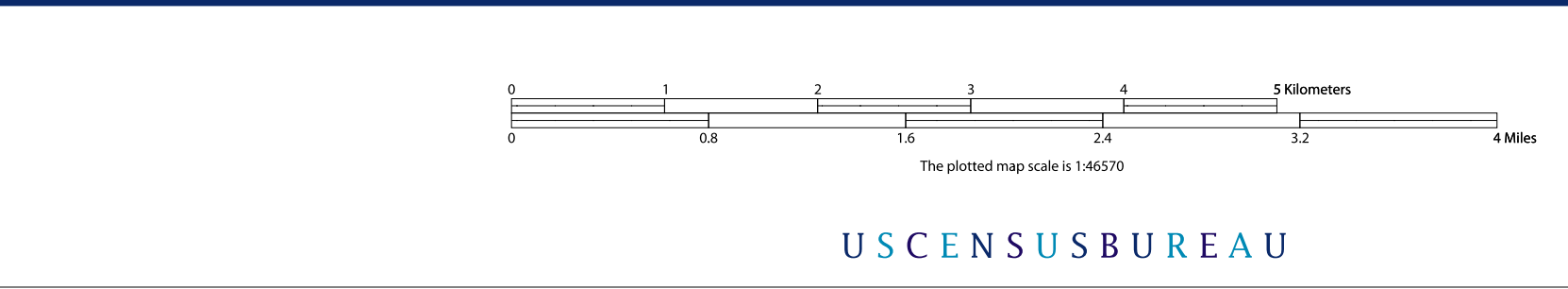
