

# **Request for Approval under the “Generic Clearance for the Collection of Routine Customer Feedback” (OMB Control Number 0690-0030)**

**TITLE OF INFORMATION COLLECTION:** Needs Assessment for Training in Climate and Hazard Adaptation: Discussion Groups

**PURPOSE:** NMFS will conduct small discussion groups in order to determine the needs of coastal disaster planning and redevelopment professionals and relevant others for training in climate and hazards adaptation planning and implementation.

**NOTE:** Respondents identified for this request are primarily members of an alliance whose members have direct relevant experience in implementing climate and hazard adaptation actions to establish “disaster-resilient communities.” In contrast, respondents for the semi-structured interviews that are anticipated as an additional information collection approach for this same study (submitted prior to this request) represent a broader group made up of coastal managers and land use planners—a group that has not yet advanced to plan implementation and would benefit from training (or be involved in the delivery or approval of such training) that draws on the experience of those who have developed and implemented disaster redevelopment plans.

**DESCRIPTION OF RESPONDENTS:** Coastal disaster planning and redevelopment professionals and relevant stakeholders in the southeast region who have experience in addressing coastal climate and hazards adaptation.
