I appreciate the opportunity to provide feedback to the CCDF Plan pre-Print and applaud the OCC for putting more rigor and consistency in the information gathered through the pre-print. Given the demands on states, it may be difficult for them to provide the depth and breadth of information requested. However, state administrators are best positioned to provide that level of feedback.

My comments, generally, address the need to use specific language to ask questions and get useful data on how states are addressing children ages 5 through 12, or schoolage children.
