**PURPOSE:**

The survey will assist the IRS assess quality and impact of tax preparer outreach/educational investments and help to identify improvement opportunities. The survey results will serve as one of the Office of Professional Responsibility’s (OPR) Performance Measure(s). The key goals of this OPR information collection activity are 1) to survey our external customers on an ongoing basis regarding their satisfaction with OPR outreach/educational products and services, 2) monitor customer satisfaction progress over time, and 3) identify improvement opportunities including communication products and skills.
