

**Request for Approval under the “DOL Departmental Generic Clearance for

TITLE OF INFORMATION COLLECTION: Off Base Transition Training Participant Survey

PURPOSE: Section 301 of The Dignified Burial and Other Veterans' Benefits Improvement Act of 2012 (Dignified Burial Act), PL 112-260, January 10, 2013, authorized the Secretary of Labor through the Veterans' Employment and Training Services (VETS) to provide the DOL Transition Assistance Program Employment Workshop (DOLEW) under 10 U.S.C. § 1144 to veterans and their spouses at locations other than military installations via a pilot program. This two-year pilot, "Off-Base Transition Training," (OBTT) program is being conducted to assess the feasibility and advisability of providing such a program to eligible individuals at locations other than military installations. At the conclusion of the pilot, GAO will assess the feasibility and advisability of providing such a program nationwide.

The purpose of the participant survey is to gauge the level of customer satisfaction from the OBTT pilot participants. One portion of assessing the pilot will be the voluntary input of the participants on their perception of the usefulness of program.

DESCRIPTION OF RESPONDENTS: The respondents are veterans and their spouses who attend an OBTT employment workshop.
